

NOTICE TO BIDDERS FOR DEBRIS REMOVAL
City of Jonesboro, AR

REQUEST FOR PROPOSAL

Sealed proposals are being accepted by the City of Jonesboro, AR at the purchasing office, 515 West Washington, Jonesboro, AR 72401 until **2:00 PM, Tuesday, February 10, 2008**. No faxed bids will be accepted. All questions may be directed to the purchasing office at (870) 932-0740.

All quotes shall be submitted in sealed envelopes addressed to City of Jonesboro, Purchasing Agent, 515 West Washington, Jonesboro, AR 72401. The envelope shall be clearly marked "**DEBRIS REMOVAL**".

The City of Jonesboro reserves the right to accept or reject or accept any part of any bid received or to waive any informalities. In accordance with 44 CFR Part 13.36(b)(8), the City of Jonesboro will make awards only to responsible contractors possessing the ability to perform successfully under the terms and conditions of a proposed procurement. Consideration will be given to such matters as contractor integrity, compliance with public policy, record of past performance, and financial and technical resources.

Work to be done:

The work to be done consists of furnishing all materials, equipment and labor for the removal and disposal of storm damage debris in the City of Jonesboro as a result of the January 27th-29th Ice Storm. This Disaster has been federally declared by the President of the United State of America.

The total amount of eligible debris to be removed under this contract is approximately ±100,000 cubic yards (not guaranteed as the actual quantity of debris is unknown). Time allotted for this work is **45 working days** with the contractor making 2 (two) passes within the city limits of Jonesboro. Contractor is responsible for debris removal and disposal on City rights of ways, including all "hangers" (2" branches or greater in size) on street right of ways (burning or grinding) and locating a operations disposal site that meets all local, state, and federal environmental regulations.

Each bidder must submit a bid bond equal to 5% of the estimated bid amount (100,000 CY). A payment and performance bond in the amount of \$1,000,000 is required upon the acceptable performance of the work in accordance with the plans, specifications, and contract documents. Said bond shall be solely for the protection of the City of Jonesboro as required by State Law.
