Police Chief Michael Yates noted the problem with bringing the condemnations all at once would be the stage of each property. Councilman Moore stated he is talking

about the obvious properties that the City knows that could be condemned.

Mayor Perrin explained he will meet with Lt. Todd Nelson and Chief Yates concerning this. Chief Yates stated the City may be able to use some of the emergency condemnation procedures for some of the properties.

Councilman Coleman inquired about a property on Bridge Street that has a hole in the roof. Code Enforcement Officer Ronnie Shaver explained the property belongs to Ms. Joyce Cummings and he has gotten her set up with grants. Discussion was then held concerning what the inside of the house is like.

Mr. Shaver then explained the process he has to follow for each property. Councilman Moore stated if Mr. Shaver can come up with a more efficient way to do the process he would like to know. Lt. Todd Nelson noted City Attorney Phillip Crego stated the condemnation process is solid and is necessary.

Councilman Fears commended Lt. Nelson for his work he has done since taking over Code Enforcement.
