Councilman Moore offered the ordinance for first reading by title only.

Councilman Street asked for more information as to why the bidding was waived. Mayor Perrin explained bidding was waived due to the trading in the other vehicle. Chief Operations Officer LM Duncan called two or three other dealerships around town but was not able to get a better trade-in value than what was offered by Cavenaugh. He noted the difference between the sale price of the new vehicle and the trade-in value of the old one is \$19,500.

Mayor Perrin explained that when he goes to Little Rock he often has five other people in the car. This allows other departments, such as Engineering, to not drive their own vehicles.

Councilman McCall asked how many miles are on the vehicle. Mayor Perrin answered it is somewhere around 150,000.

Questions were raised concerning the emergency clause on the ordinance. City Attorney Carol Duncan stated certain financial matters allow for the emergency clause, but she couldn't think of a reason to have the emergency clause on this particular ordinance that would legally justify it.

Councilman Frierson motioned, seconded by Councilman Moore, to suspend the rules and waive second and third readings. All voted aye.

Phillip Cook, 5216 Richardson Drive, questioned what the need is for the emergency clause. Mayor Perrin answered there is no need for it since there is no rush. They will not be passing the emergency clause. Mr. Cook stated that since the Council is waiving the second and third readings, it will be similar to adopting the emergency clause since tonight will be the only time the ordinance is read. Mayor Perrin noted the ordinance will not go into effect for another 30 days.

Mr. Cook then questioned why the new vehicle is needed. Mayor Perrin noted that they try to rotate vehicles every two to three years. His current vehicle is almost three years old. He drives a lot back and forth to Little Rock, as well as other cities, on trips that include other people as well.

Councilman Street asked how many units could be put on the property if the property was left R-2. Mr. Spriggs answered it would be 12 units per acre on average. What the applicants are proposing does not go above the allowable density for that site; rather, the R-2 district has stringent guidelines that require a cookie-cutter approach. The applicant is doing single-story buildings on this phase. The new zoning allowances have a better layout from a zoning perspective.

Councilman Street then questioned if there was any opposition to the rezoning. Mr. Spriggs answered no, no one spoke in opposition to this issue.

8. MAYOR'S REPORTS

Mayor Perrin reported on the following items:

There is a building at the airport that can be leased. ASU's Economic Development Department was in the building. It's about 3,600 square feet. They are going to look at the building to fix it up. The money from the lease goes to the Airport Commission, not the city. If anyone is interested, let them know so they can be referred to the airport manager.

He received a letter from Governor Asa Hutchinson's office saying the Parks & Rec Department has been approved for a grant of \$61,000 to resurface the tennis courts at Earl Bell.

Tomorrow, he, Mr. Duncan and Traffic Engineer Mark Nichols will be attending the Highway Commission meeting. They will have a minute order to add four pedestrian crosswalks to Johnson Avenue. That project will be a partnership between the city, ASU and the Highway Department. Total cost is around \$150,000. They will also discuss the Parker Road extension project to Washington Avenue. The project was bid out. The low bid was \$1.4 million, while the high bid was \$4.1 million. The minute order for the project will be approved tomorrow.

The owners plan to demo the building at 411 Union, but the city has not received anything in writing.

The Building Facilities Committee met last week to discuss several issues. Several projects will be brought forward to the Council.

He is pleased that the city's Facebook page visits have increased.

Sunday he attended a community conversation about race relations. Police Chief Rick Elliott was on the panel. He thought it was a great meeting. They will continue to do those meetings in town.

They are still interviewing for the Director of Communications position. The new Human Resources Director will start next week. Dewayne Douglas has a master's degree in human resources and has been teaching at Mid-South School in West Memphis. He also worked for Regions Bank in human resources.

He spoke with the director of the Department of Finance & Administration. He is going to be receiving a list of people who are paying the state in sales taxes, so they can compare it to privilege licenses in the city.
