RESOLUTION AUTHORIZING THE CITY OF JONESBORO, ARKANSAS TO ENTER INTO AGREEMENT WITH THE DELTA DENTAL ARKANSAS FOUNDATION TO RECEIVE COVID-19 RELIEF FUNDING

WHEREAS, the City of Jonesboro, Arkansas has been awarded the Delta Dental Arkansas Foundation Covid-19 Relief Fund grant in the amount of \$2,500; and,

WHEREAS, funds will be utilized to purchase hygiene items for the homeless; and,

WHEREAS, the City of Jonesboro, Arkansas passed the 2020 Budget in Resolution RES-19:201, which will need to be amended in order to reflect the award amount; and,

WHEREAS, the grant is 100% funded with private funds and there is no cost to the City of Jonesboro.

NOW; Therefore, be it resolved by City Council of the City of Jonesboro that:

SECTION 1: The City of Jonesboro, Arkansas will enter into agreement with the Delta Dental Arkansas Foundation.

SECTION 2: The city's 2020 budget will be amended to include the grant award of \$2,500.

SECTION 3: The Mayor and the City Clerk are hereby authorized by the City of Jonesboro City Council to execute all documents necessary to effectuate this agreement.

SECTION 4: The Grants and Community Development Department is hereby authorized by the City of Jonesboro City Council to execute all documents necessary to accept this agreement.

Requirements: The following terms are conditions of this grant:

- 2. Grantor reserves the right to review all expenditures for the project to ensure spending is consistent with project justification.
- 3. Grantee will provide a final progress report the earlier of (i) August 3, 2020 or (ii) within 30 days of when funds are otherwise expended. Reporting forms will be accessible throughout the duration of the grant period via Foundant.
- 4. Grantee agrees that it shall repay any portion of the grant funds not used in accordance with these terms to Delta Dental of Arkansas Foundation, Inc. To request a grant extension, complete a Grant Modification Request in Follow-Up Section of Applicant Dashboard.

To the extent permitted by applicable law, Grantee shall be responsible for its acts of misfeasance, malfeasance and/or malpractice associated with the disbursement of grant funds and the services purchased using said funds, and the Grantee accepts all legal and fiduciary responsibility for the use of Delta Dental of Arkansas Foundation, Inc. grant funds.

Grantee accepts the Delta Dental of Arkansas Foundation, Inc. grant under the above terms and conditions.
