The Arkansas Recreation and Parks Association selected Jonesboro Parks and Recreation for three awards. Program of the Year, this is huge. We have all seen it. It reaches another milestone when it is in its 40th year here in our community and it is at the Southside Complex. This is the longest running youth tournament in Arkansas. The three-day event is beneficial not only for young players, but also for Jonesboro hotels, restaurants, and businesses. Patti Lack, 4108 Forest Hill Road, said, I appreciate you guys pulling this. I did a little research on this. In fact, I did some research a couple of years ago. I want to make a couple of statements and have some questions answered. At the top where it says purchases will be made through state bids and in Section 3 it says the purchase of

autos from state bid dealers is authorized. So, has this already been approved? City Attorney Carol Duncan said, no. Ms. Lack said, I know you guys approve it here, but the wording of will and is authorized, I am a little confused on those two words. Ms. Duncan said, no, it has not been approved yet. That is what they are authorizing. Ms. Lack said, okay, so did the City of Jonesboro just go to one dealership or did we do some competitive bidding for these 48 vehicles? I see it is a state bid. Ms. Duncan said, state bid is competitive bidding. If it is under the state bid contract, they have already done the competitive bidding and we are allowed to purchase on that without bidding. Ms. Lack asked, so they go out and look at vehicles. Ms. Duncan said, the state does it. Ms. Lack asked, do you say what kind of car you want? Ms. Duncan said, they already have a list and you just purchase through the state bid contract. Ms. Lack said, oh, well, that is kind of nice.

Councilmember Bobby Long said, to just add to that, these state bids are at triple net. A lot of times, plus a little bit. So, it is a price far below what the normal retailer could go and get. Ms. Lack said, okay. I believe, I think I remember a couple of years ago, the city doesn't pay sales tax, correct? Is that correct? Sales tax on cars. Mayor Copenhaver said, I will have to find that out. That is correct. Ms. Lack said, okay, good. One thing that I did and this was two years ago and I know that they inventory of our fleet of cars and this does include fire engines and every car that we have here is that I requested a car report, a fixed asset audit report and just by chance I had it left on my computer. On this report here, it shows that the City of Jonesboro, two years ago or almost two years ago, had 430 vehicles that we owned on there. That is a lot of vehicles that we have and I understand that they are all mixed in between all of the departments. So, when I saw this request of the automobiles on that, I decided that I was going to look at and I just gave random looks of different departments of how many cars each one of the departments had. And, one of them, I just took Code Enforcement. On this report, it showed that two years ago, we had five of them and they want three of them now so that is going to be eight. And, today, I asked how many employees are in the Code Enforcement Department and I was told that there are six. So, we are going to have eight cars. So, my question is, what is the city going to do with those left over vehicles in that department?

Mayor Harold Copenhaver said, I will address that point blank. This administration along with Finance, that is exactly what we are doing, we are addressing the issues because our inventory is aging so when we purchase a car, we also want a car to go out of the inventory as well. So, we are working with each department and addressing the vehicles that they need, not necessarily the ones they want, but that they necessitate. It is also important that we revitalize our fleet at this point and time because it is aging. Many of our police vehicles are ten to fourteen years of age. We still have them on the lot. We lost three last week to accidents. It is an ongoing occurrence, but I can assure you and the community that this administration is addressing and I, an old insurance agent, I do not want an abundance of vehicles in our fleet. But, we have to have a fleet that is good and in working order. Ms. Lack said, absolutely. And, the Police Department, I don't have a problem with. I guess what I am trying to look at is that looking at each one of the departments, you know, even like the Engineering Department I looked at. And, on the report, it had ten cars that we had on the report two years ago and they are asking for twelve and there are twelve employees. So, I guess my question is that with the number of cars that we have with each one of the departments, are these cars being taken home by the people in the departments on a daily basis or a weekend? Do they have an expense report? I also learned that if you take a car home, you have to report it on your W-2 form. So, those are just some of the questions that I am kind of curious about. Are they keeping the cars here and then they drive their own car here and then they use them while they are

working or do they use them all weekend long?

Mayor Harold Copenhaver said, yes. Councilmember Joe Hafner said, I think on the take home, it is not just if you take it home, it is if you use it for personal reasons. I know, like police, they take home cars but I don't think they drive it to the grocery store on the weekends. Ms. Lack said, right. Councilmember Hafner said, there is more to it than just taking it home. It is not that simple. You have to use it for personal reasons and that is when the IRS tables and stuff come in, but, I mean, there are several layers to the onion. I think a lot of time is spent by the departments and the department heads going through this. Mayor Copenhaver said, we are really pulling this together and tightening the stirrups so to speak. Ms. Lack said, I appreciate that. Mayor Copenhaver said, in that, Steve is there anything else that you would like to add to that why we are on this subject? Finance Director Steve Purtee nodded his head no. Mayor Copenhaver said, okay, thank you. Councilmember Chris Moore said, and I don't know and it may go to Ms. Lack's questions, but we just had an auction three weeks ago and we had a variety of city vehicles that were being disposed of. So, the vehicles on your list from two years ago, we are not adding the new vehicles and keeping them all. Is that what you are getting at? Ms. Lack said, I guess that is what I am asking. I feel like we have a lot of vehicles and I understand that there is going to be a shortage and I appreciate the tightening the budget part of it because even with used cars now they are selling for more. We have a lot of cars that we could make a little bit of money on. I guess when you look at the amount of it, it is just a concern I think that citizens have when looking at the dollar amount, but if we are tightening up the budget and we are looking at the cars, that is what we need to do. So, it was just a question that needed to be addressed. Councilmember Moore said, I also have to say that I was at the auction. Ms. Lack asked, did you buy one? Councilmember Moore said, no, they were pretty despicable. By the time the city was done with them Patti, the city had gotten every mile out of them and I don't think that there was a single one that was auctioned off that didn't have some mechanical problem. They pass them down and use them until they are just about, well, they are beyond serviceable on most of them. Ms. Lack said, okay, well, I just wanted to make sure and I realize that and I appreciate you using the money the way that we need to and not spending it just on the wants part of it. So, thank you.

Mayor Copenhaver said, and well, again, to add to that, we had a lot more requests than what is on this page. And, we went to the departments and said we need to know truly why and what your need is for that vehicle and how to address that moving forward in your department. So, again, we have addressed all of that here. The availability and timing of this is important because vehicles that we asked for earlier in January, we still have not received. We are just now receiving some. And, so, with the availability of this, we are able to move forward saving taxpayer dollars instead of moving into next year when the vehicle prices could be higher. Ms. Lack said, sure. Alright, I appreciate it. Thank you. Councilmember John Street said, Mayor, just something to add, a lot of people don't realize that a lot of our departments get called out at night for various reasons. So, they may take that vehicle home, but if the Street Department has to come out in a flood to do something or block off a road because a culvert washed out or the Engineering Department has to go out to fix a traffic signal that has been damaged or struck by lightning or something, so many of our different departments have to have a vehicle to go out to take care of these things after normal hours. Mayor Copenhaver said, well said, well said, thank you. Councilmember Joe Hafner said, just to be clear too, Legislative Audit was checked with concerning the establishment of this equipment depreciation fund and they were perfectly fine with it. I know it is a new fund, but Legislative Audit did check off on it. Mayor Copenhaver said, thank you Mr. Councilmember.

So, if we vote to hear this appeal, will we be hearing specifically the amended motion that they denied about the 12'x48' sign or will we be hearing the original? City Attorney Carol Duncan said, yes, it would be an appeal of the denial so I guess it would be the amended motion that they agreed to. Because just to hear an appeal on an appeal's basis without a reason, seems to be in error. Ms. Duncan said, it is attached to the record what all they filed, but I don't know. Councilmember Moore said, I would think that a proponent would have to present the reason for appeal. As Charles has said in the past, we would have to have a reason to overthrow the MAPC decision. Councilmember Charles Frierson said, and to get to that point, we need someone from MAPC telling us why the aspects and why they turned it down and we don't have that

So, we hope that we have done a good service to our employees because they are a key asset to our community and this is one of the big benefits and the

reasons why they are working here. I appreciate your support council by approving this.
