**NOW, THEREFORE**, for and in consideration of the sum of Ten and No/100 Dollars (\$10.00) in hand paid to Assignor by Assignee, and other good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged by Assignor and Assignee, Assignor and Assignee hereby covenant and agree as follows:

1. Assignor hereby unconditionally and absolutely assigns, transfers, sets over and conveys to Assignee all of Assignor's right, title and interest as landlord in and to the Sublease and all of the rights, benefits and privileges of the landlord thereunder, including without limitation all of Assignor's right, title and interest in and to all rentals thereunder for the period from and after the date hereof.

2. Assignee hereby assumes all liabilities and obligations of Assignor under the Sublease which arise on or after the date hereof and agrees to perform all obligations of Assignor under the Sublease which are to be performed or which become due on or after the date hereof.

3. Assignor understands and acknowledges that, should Assignee fail or refuse to perform its duties under the Sublease, that Assignor shall remain fully liable for performance thereof and is in no way released by the execution of this instrument. This Assignment shall inure to the benefit of and be binding upon Assignor and Assignee, their respective legal representatives, successors and assigns. This Assignment may be executed in counterparts, each of which shall be deemed an original and all of such counterparts together shall constitute one and the same Assignment. Assignor and Assignee ratify and affirm all terms and provisions of the Sublease and do hereby acknowledge that sublandlord and master landlord have fully performed thereunder.
