City of Jonesboro existing Storm Water Drainage Ordinance appeals requires MAPC approval.

Applicant requests an appeal for waiver of Storm Water Management Requirement. Staff recommends that the matter be referred to the Storm Water Management Board.

The Metropolitan Area Planning Commission agreed to recommend to the Public Works Council Committee and City Council that the following policy and procedure be adopted by the earliest time permitted by law for the processing of withdrawal requests of rezoning, annexations and conditional use applications.

The following stipulations were agreed upon:

Section 1: Only one withdrawal shall be allowed as of right after the 24th day of the month following the application filing for a rezoning, annexation or conditional use; and,

Section 2: On or after the 2nd time withdrawal granted, the applicant must wait 90 days before resubmitting the same or similar petition involving the same land and use; and,

2a. Exception Clause: Under extenuating (emergency) circumstances, the Planning Commission or City Council may consider and grant a request to waive the 90-day restriction on the 2nd time request for withdrawals. Section 3: Third-time withdrawal requests will default to the most current ordinance requirement for denied rezoning petitions.

A motion was made by Secretary Marvin Day, seconded by Lonnie Roberts Jr., that the matter be referred to the Storm Water Management Board.Other Communications be Approved. The motion CARRIED by the following vote:
