ORDER OF CONFIRMATION OF ANNEXATION


On this 31st day of March, 1987, comes on for hearing before the court the above styled cause and matter now appearing for the approval and confirmation of the annexation of said lands heretofore annexed to the City of Jonesboro, Arkansas, by order of this court dated February 24, 1987. The petitioners appear by and through their attorney, Paul E. Hopper. The matter is heard upon the pleadings and orders with exhibits thereto, filed herein, the affidavit and certificate of the Circuit Clerk of Craighead County, Arkansas, certifying that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County to prevent the annexation of said lands and territory herein, from all of which, together with other things and matters before the court, the court doth find:

That said lands herein were annexed to the City of Jonesboro by order of this court dated February 24, 1987, and that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County, Arkansas, to prevent said annexation within thirty days from the date of said order of annexation and that said annexation was in all things done in conformity with the laws of the State of Arkansas and therefore should be approved and confirmed; that said territory should be accepted by the City of Jonesboro, Arkansas.

That said lands and territory annexed to the City of Jonesboro, Arkansas, are described as follows, to-wit:

A part of the Southwest Quarter of the Southeast Quarter of Section 28, Township 14 North, Range 4 East, being more particularly described as follows: Commencing at the Northeast Corner of said Southwest Quarter of the Southeast Quarter and run South 89° 57' West along the 40 acre line 1012.1 feet to the point of beginning proper; thence South 89° 57' West 240 feet; thence South 0° 42' West 336.6 feet; thence North 89° 52' East 340 feet; thence North 0° 42' East 236.3 feet; thence South 89° 57' West 100 feet; thence North 0° 42' East 100 feet to the point of beginning proper, subject to easement along the South side thereof.

IT IS, THEREFORE, BY THE COURT, CONSIDERED, ORDERED, ADJUDGED and DECREED that the annexation of said lands and territory herein to the City of Jonesboro, Arkansas, be in all things approved and confirmed and the proceedings before this court be and are hereby confirmed. The Clerk of this Court be and is hereby authorized and directed to certify one copy of the plat of such annexed territory with one copy of this Order of the County Court and the Ordinance of the City of Jonesboro, Arkansas, and forward one copy of each to the Secretary of State who shall file and preserve the same and shall forward one copy of this order to the Director of the Tax Division of the Arkansas Public Service Commission who shall file and preserve the same and shall notify all utility companies having property in said municipality of this annexation of property in said municipality and the clerk is directed to forward a certified copy of this order to the City of Jonesboro, Arkansas.
