Chairman Street asked what the change order is for. Mayor Perrin answered the change order is for a bond and for the replacement of the bathroom and foyer ceilings. He noted there will be another change order for this project, but this change order amount is for \$32,383 with \$10,000 of that being for the bond.

Mayor Perrin stated he is having the City's maintenance department go through the building and come up with a price list, which he will take to the Building Facilities Committee. He added at this time he knows the building will have to have a new roof. He noted the YMCA has asked for a 48 hour extension so they can finish moving out of the building, which should be by Friday.

Councilman Dover asked what the building could be used for. Mayor Perrin answered he is wanting to get a cost estimate to determine if the building should be renovated or

torn down, but it could be used it as a Senior Center.

COM-12:038 Discussion concerning closing of an alley by Abilities Unlimited

Chairman Street explained this information is just FYI. He added the adjoining property owner does not want to close the alley, but the person who wants to abandon the alley has proposed to re-route the area and will also give an egress and ingress easement to the other property owner.

Darren May, representing Abilities Unlimited, stated they own an assisted living facility at 710 Walnut and all the property on the east side of Walnut between Jefferson and Matthews. He added they have had issues with the traffic from the apartment complex east of their building. He further explained they did a survey and thought they could close the alley on both sides of the property that they own, but City Attorney Phillip Crego determined they could not do that without all of the property owners consent. He noted there are two other property owners and one has agreed to close the alley, but the other one hasn't because the other owner would have nowhere to go if they closed the alley. He added Abilities Unlimited has agreed to give that property owner an easement for the property where the old church was located so the tenants to the apartment complex could use it to access Matthews Avenue. He noted the adjoining property owner agreed to look at that option, but has not met with him to discuss the issue.

Discussion was held concerning issues that they have had with the apartment complex.

Councilman Chris Moore stated if they can't get the alley closed then the City should be able to help Mr. May in terms of policing the area. Mr. May stated the other property owner will not lose his access to his property because the easement would allow him to turn onto Matthews instead of going straight to Vine Street.

Mayor Perrin stated he would be glad to try and set up with a meeting with the adjoining property owner Jason Willis and Mr. May to discuss this issue. He added he will have Code Enforcement and the Police Department look into the problems he stated he has been having.

Mayor Perrin asked if the alley is closed will it be fenced. Mr. May answered yes and

they are willing to gate it so access can be obtained in case of an emergency.
