



**City of Jonesboro Metropolitan Area Planning Commission
 Staff Report – RZ08-22: Johnson Ave. - Robinson
 Huntington Building - 900 W. Monroe
 For Consideration by the MAPC on Tuesday, October 14, 2008**

REQUEST: To consider rezoning a parcel of property containing approximately .38 acres more or less.

PURPOSE: A request for rezoning from R-1 Residential to C-3 General Commercial.

OWNER: Marjorie Robinson 4207 E. Johnson Ave., Jonesboro AR.

LOCATION: 4207 & 4209 E. Johnson Ave.

SITE DESCRIPTION: Tract Size: Approx. .38 acres
 Frontage: Approx. 100 feet (Johnson Ave.)
 Topography: Flat
 Existing Dvlpmt: Residential

SURROUNDING CONDITIONS:	<u>ZONE</u>	<u>LAND USE</u>

HISTORY There are two residences on this property.

ZONING ANALYSIS: City Planning Staff has reviewed the proposed Zone Change and offers the following findings.

COMPREHENSIVE PLAN/ FUTURE LANDUSE MAP

The 1996 Comprehensive Plan Future Land Use Map (page 24) shows the area recommended as Thoroughfare Commercial. This area is pending a restudy on the land use map by the Land Use Advisory Committee and will likely maintain a commercial status.

Pertinent Zoning Ordinance sections include Section 14.44.05(b), ‘change in District Boundary’, beginning on page 104.

Approval Criteria- Section 14.44.05, (5a-g)- Amendments:

The criteria for approval of a rezoning are set out below. Not all of the criteria must be given equal consideration by the planning commission or city council in reaching a decision. The criteria to be considered shall include but not be limited to the following:

- (a) Consistency of the proposal with the Comprehensive Plan
- (b) Consistency of the proposal with the purpose of the zoning ordinance.

- (c) Compatibility of the proposal with the zoning, uses and character of the surrounding area;
- (d) Suitability of the subject property for the uses to which it has been restricted without the proposed zoning map amendment;
- (e) Extent to which approval of the proposed rezoning will detrimentally affect nearby property including, but not limited to, any impact on property value, traffic, drainage, visual, odor, noise, light, vibration, hours of use/operation and any restriction to the normal and customary use of the affected property;
- (f) Length of time the subject property has remained vacant as zoned, as well as its zoning at the time of purchase by the applicant; and
- (g) Impact of the proposed development on community facilities and services, including those related to utilities, streets, drainage, parks, open space, fire, police, and emergency medical services.



Findings:

The applicant is hoping to market the proposed site for commercial use. The zoning plat shows a number of structures abutting that are residential and the property immediately west was recently rezoned to C-4 and has not been sold for redevelopment.

Although the trend for this area has been moving towards commercial, Staff cautions the Commission that care should be taken to prevent the existing homes from being converted to commercial in the interim and lack compliance to every ordinance and building code. Therefore, Staff is recommending that the MAPC place a limited use overlay over the subject property, requiring a redevelopment plan be submitted to the Commission for final approval with the condition that any commercial use of the existing structure(s) shall meet all city codes and standards for building, parking and site design, and that the redevelopment plans be submitted in the future for MAPC review and approval. Cross access easements should also be required.

Conclusion: The Planning Department Staff finds that the requested Zone Change submitted by Marjorie Robinson should be reviewed based on the observations above. In Case of RZ-08-22, the

request to rezone property from R-1 to C-3 Commercial Limited Use Overlay should be modified by MAPC and recommended to the Jonesboro City Council as C-3 General Commercial, Limited Use Overlay; with the condition that any commercial use of the existing structure(s) shall meet all city codes and standards for building, parking and site design, and that the redevelopment plans be submitted in the future for MAPC review and approval. Cross access easements should also be required.
