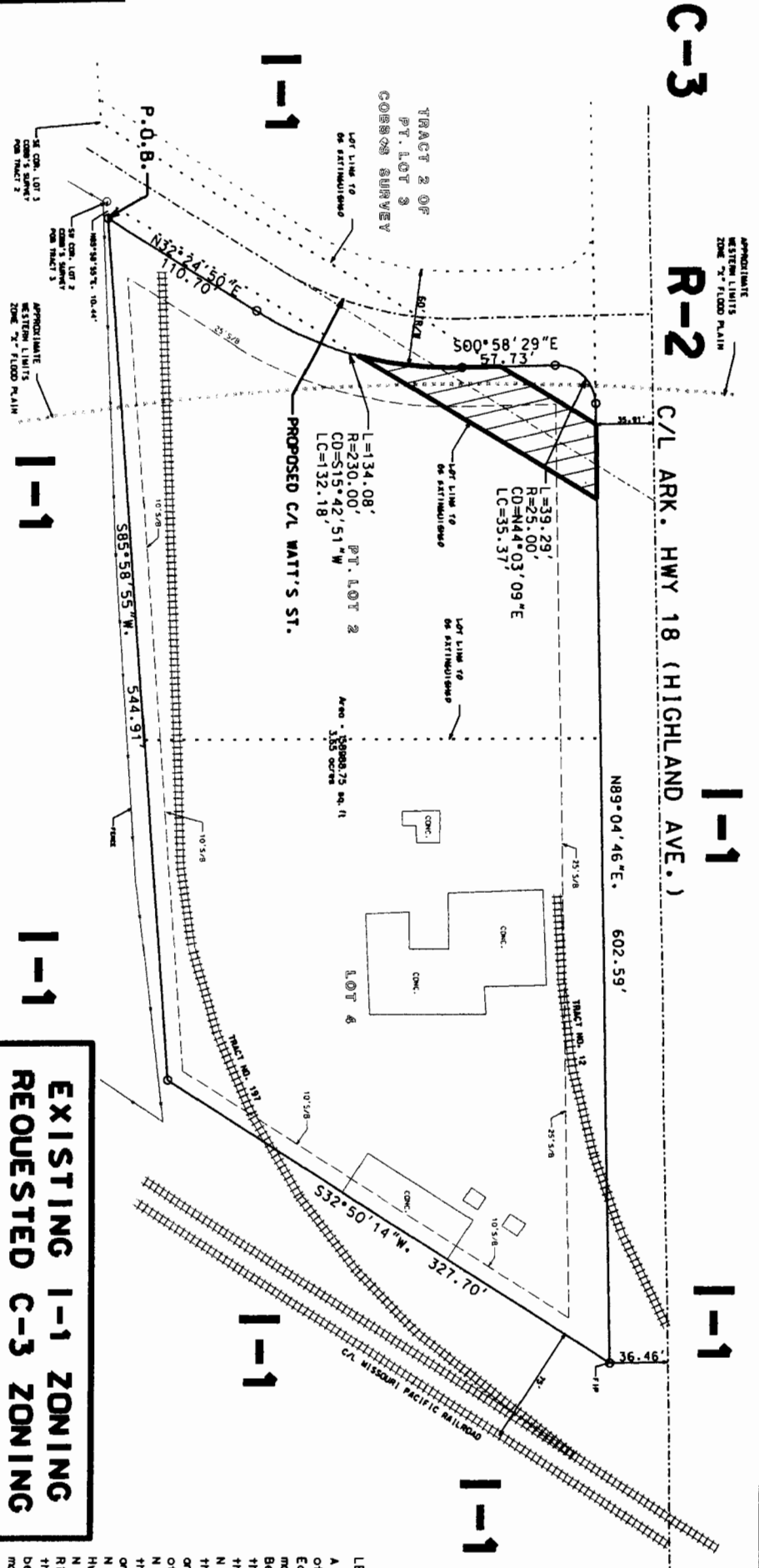

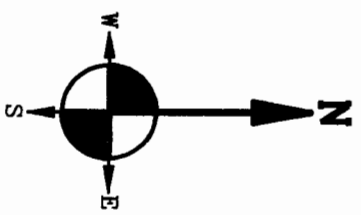

LEGAL DESCRIPTION (AS SURVEYED):
 A part of Lots 2 and 4 of the Cobb's Survey of the Northeast Quarter of the Northeast Quarter of Section 27, Township 14 North, Range 4 East, Craighead County, Arkansas. City of Jonesboro, Arkansas, being more particularly described as follows:
 Beginning at the Southwest Corner of said Lot 2; thence N 85°58'55" E, a distance of 10.44 ft., to the POINT OF BEGINNING; thence along the Eastern Right-of-Way of Watt's Street as follows: N 32°24'50" E a distance of 110.70 ft., to a point on a curve, then along a curve to the left, said curve having a radius of 230.00 ft., on an arc of 134.08 ft., a chord length of 132.18 ft., and a chord bearing N 00°58'29" E a distance of 57.73 ft., to a point on a curve, then along a curve to the right, said curve having a radius of 25.00 ft., on an arc of 39.29 ft., a chord length of 35.37 ft., and a chord bearing of N 44°03'09" E to a point on the South right of way line of Arkansas Hwy 18 (aka Highland Ave.); thence following said Right-of-Way, N 89°04'46" E, a distance of 602.59 ft., to a point; thence leaving said Right-of-Way, S 32°50'14" W, a distance of 327.70 feet to a point; thence S 85°58'55" W, a distance of 544.91 feet to a point; said point being the POINT OF BEGINNING, said tract containing 3.65 acres, more or less, and being subject to easements and Rights-of-Way for roads and other purposes.

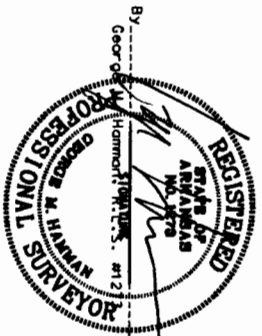

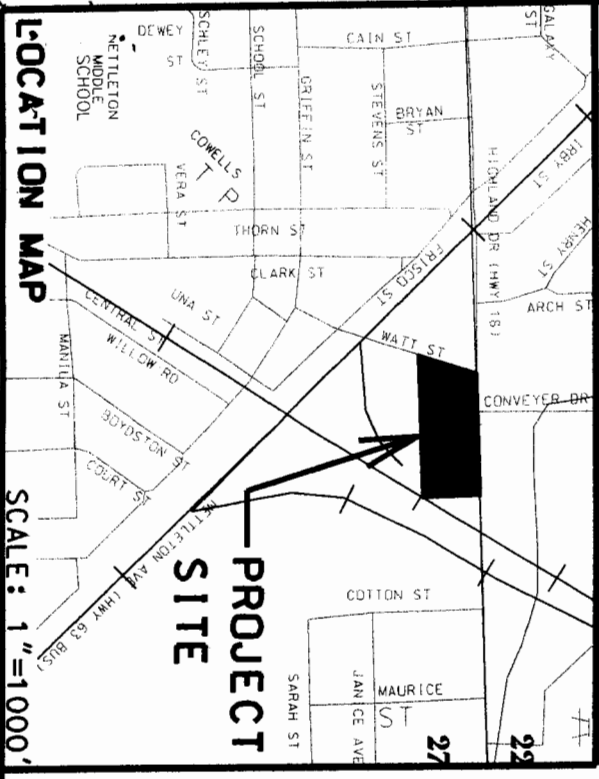
