AN ORDINANCE ADOPTING BY REFERENCE THE 2012 INTERNATIONAL PROPERTY MAINTENANCE CODE TO THE JONESBORO CODE OF ORDINANCES WITH RESPECT TO MULTI-FAMILY HOUSING IN THE CITY OF JONESBORO

*Chairman Johnson added they need some clarity on the code. Councilman Moore stated with a public hearing citizens will be able to review the code and ask questions. He noted they may need to hold the public hearing at 6 p.m. in order to accommodate people who work during the day. Councilman Vance explained the code is for three units and above, but he would like to see the committee come back and look at all residential then look at commercial and industrial. He further explained the city needs something to help maintain the integrity of the buildings.*

*Mayor Perrin stated he has mentioned recently possibly pulling the code from tonight's agenda due to confusion. The code is only for three doors or more, but there are also a lot of problems with rental homes because the homeowners are not keeping up the property. As long as a public hearing can be held and a committee be*

*appointed, the city shouldn't drag out looking at other areas. He noted the problem in Jonesboro isn't necessarily residential homes that are owner-occupied; rather, its homes that are rented out and aren't properly maintained. He stated the city needs code to take care of problems like that.*

*Councilman Moore noted that at the neighborhood meetings held earlier this year throughout the city the number one issue mentioned by citizens was code enforcement. Mayor Perrin agreed.*

*Councilman Burton stated this code was a recommendation from the Multi-family Housing Moratorium Committee, which is why it deals with multi-family and not residential. He explained the committee wasn't charged with looking at residential, commercial or anything else. The committee was asked to look specifically at multi-family.*

**Councilman Moore motioned, seconded by Councilman Gibson, to recommend the ordinance to the full Council with the following provisions: that the ordinance be held to three consecutive readings and that the Mayor hold a public hearing on an off-Tuesday during that timeframe so the public can come in and discuss the code and ask questions. He also stated the Mayor should form a committee to review any other recommendations that may be warranted. The motion PASSED with the following vote.**
