TO A POINT; THENCE RUN S 89°31'00" W A DISTANCE OF 1116.69 FT. TO A POINT ON THE EAST RIGHT OF WAY LINE OF WIMPY LANE; THENCE RUN N 01°16'46" E ALONG SAID EAST RIGHT OF WAY LINE A DISTANCE OF 240.11 FT. TO A POINT ON THE SOUTH RIGHT OF WAY LINE OF U.S. HIGHWAY NO. 49; THENCE RUN N 89°31'00" E ALONG SAID SOUTH RIGHT OF WAY LINE A DISTANCE OF 1120.34 FT. TO THE POINT OF BEGINNING, CONTAINING 6.16 ACRES.

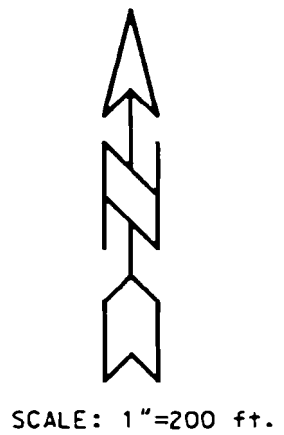
