Councilman Dover offered the ordinance for first reading by title only.

Councilman Street stated he has been contacted by concerned citizens, but noted the rezoning was approved by the MAPC with stipulations regarding the future use of the land. Ms. Christie Jordan, Executive Director of the Food Bank of NEA, noted those stipulations are in the proposed ordinance. She explained the property has been used commercially even before they moved into the building. She further explained the reason for the request for rezoning is to match the zoning of the property with what it is actually being used for.

Councilman Frierson questioned what may reside on the property in the future if the property remained non-conforming as opposed to being rezoned. City Planner Otis Spriggs answered if the ordinance passes, new uses will be evaluated by the Planning Commission. He added if the property stays non-conforming without the rezoning and the use changed, then the use would have to be consistent with the current use and questions would be answered by the Board of Zoning Adjustments. City Attorney Phillip Crego agreed with Mr. Spriggs in that if the property remains non-conforming, then future uses will have to be similar to the current use. He noted there are also restrictions on non-conforming uses, such as regulations on expansions.

Discussion was held concerning the uses excluded by the MAPC. Mr. Spriggs stated the permitted uses in the ordinance are consistent with C-4 Neighborhood Commercial and exclude adverse uses. He added the Council has the option to modify the recommendation of the MAPC.

Ms. Jordan noted the Board of Directors has not made a decision as to what they will do with the property in the future. Mr. Spriggs stated the property next door was also rezoned C-4 recently.

Councilman Moore asked for Mr. Spriggs to send the Council members a list of approved uses for the property.

8. MAYOR'S REPORTS

Councilman Moore reported on the following items as requested by Mayor Perrin:

He presented the Council members with ward boundaries for each of the Council members. He noted it is for informational use and there are a few wards that will have population changes.

He asked for an update concerning the condemnation of the apartments at 1609, 1613 and 1617 West Nettleton Avenue that are currently in litigation with Bank of America. Code Enforcement Officer Ronnie Shaver recommended moving forward with razing of the properties. He explained Maintenance Director Keith Sanders has had to re-board the property because people keep entering the building. He also stated there has been reports of trash. He noted the property was condemned on January 18th, but they were given a 60-day extension in order to move forward with purchase of the property. He added that he has notified the litigation attorney that he would be recommending to the Council to move forward with razing of the structure. Mr. Shaver stated he has not heard from Bank of America regarding his recommendation and has not heard from Habitat for Humanity at all since being granted the extension. Police Chief Michael Yates supported Mr. Shaver's recommendation for razing the structure. Mr. Shaver noted there is no action needed by the Council; rather, he wanted to inform the Council of what his recommendation is and what will be happening with the property. Councilman Frierson motioned, seconded by Councilman Vance, to support Code Enforcement to complete the condemnation of these properties. All voted aye.
