The party of the first part is the owner of certain property at 1405 Flint Street, Jonesboro, Arkansas, Parcel Number 9A.

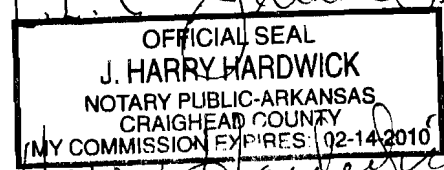
The party of the second part is in the process of improving West Nettleton Avenue.

Now, Therefore, be it agreed between Tangles Hair Salon of Jonesboro, L.L.C., and city on 8th day of February, ~~2000~~ 2001

1. Tangles Hair Salon of Jonesboro, L.L.C., in consideration of the agreement hereinafter made by city, grants to city a right-of-way for construction and maintenance of a street over the land Tangles Hair Salon of Jonesboro, L.L.C., in City of Jonesboro, Craighead County, Arkansas, or particularly described as follows:

DESCRIPTION OF PERMANENT RIGHT-OF-WAY

PART OF LOT 2 IN BLOCK 1 OF COLE'S SECOND ADDITION TO THE CITY OF JONESBORO, CRAIGHEAD COUNTY, ARKANSAS, AS RECORDED IN DEED BOOK #26, PAGE #402 IN THE OFFICE OF THE CIRCUIT COURT CLERK AND EX-OFFICIO RECORDER, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGIN AT THE NORTHEAST CORNER OF LOT 2 IN BLOCK 1 OF COLE'S SECOND ADDITION TO THE CITY OF JONESBORO, CRAIGHEAD COUNTY, ARKANSAS, THENCE SOUTH 1°22'20" WEST ALONG THE EAST LINE OF LOT 2, AFORESAID, 72.00 FEET TO THE SOUTHEAST CORNER OF LOT 2, AFORESAID; THENCE NORTH 88°37'43" WEST, ALONG THE SOUTH LINE OF LOT 2 AFORESAID, 6.03 FEET; THENCE NORTH 0°52'11" EAST 72.00 FEET TO THE NORTH LINE OF LOT 2, AFORESAID; THENCE SOUTH 88°37'43" EAST, ALONG SAID NORTH LINE, 6.66 FEET TO THE POINT OF BEGINNING, CONTAINING, 0.011 ACRES, (456.92 SQUARE FEET).

2. Tangles Hair Salon of Jonesboro, L.L.C., warrants the right-of-way against anyone claiming it or in any manner preventing free and unobstructed use of it by city.

3. City, in consideration of the grant of right-of-way aforesaid, agrees to construct, maintain and improve the property through the use as is set forth herein.

4. This agreement shall inure to and bind the heirs, executors, administrators, successors and assigns of the parties and shall constitute a covenant running with the land of Tangles Hair Salon of Jonesboro, L.L.C.
