
WITNESSETH:






Dear Mr. Scott:

I have appraised the above property as of December 6, 2001, and find the market value to be \$20,240. In accordance with your instructions, I have reduced the lot size by the "amount of taking" for the purpose of widening Nettleton Avenue. The remaining value is \$19,188 or a difference of \$1,052 which is the just compensation due the owner. In addition, 7 trees will be destroyed. A fee of \$3,500 will be paid for this loss bringing total compensation to \$4,552.
