The Court further finds that the allegations in the Petition are true, that the limits of the territory to be annexed have been accurately described and an accurate survey thereof reflecting the lands to be contiguous to the existing city limits of Jonesboro has been filed in this cause; and that the prayer of the Petition should be granted.

IT IS THEREFORE, BY THE COURT, CONSIDERED, ORDERED AND ADJUDGED that the above and attached described lands be and the same are hereby annexed to the City of Jonesboro, Arkansas, subject only to confirmation by the City Council of the City of Jonesboro in the manner prescribed by law.
