8. MAYOR'S REPORTS

The Mayor gave the following report:

The Fire Department received a \$185,000 grant from Homeland Safety. The grant is 20% match, with the matching funds coming from CWL. The money will be used for the hydrant program.

The administration worked with G&K to renegotiate their contract. Building Maintenance Director Keith Sanders was able to save \$23,265 annually.

Additional training will begin in March with equipment purchased from the grant received from Senator Bookout.

Sales tax is down \$7,099 from 2009. He noted a 2.5% reduction in sales tax was budgeted for 2010. He stated the big indication will be when the numbers from December's sales tax are received.

Work is being done on the employee handbook and the business continuation training has been completed.

They are still working on real estate, so the City can receive bids for property. An appraisal was done on the old fire station on the corner of Caraway & Matthews.

They should receive an agreement from the Corps of Engineers soon regarding the drainage. He added the agreement will include a price and will be sent out to the Council members so discussion can start.

Ms. Joy Trauth sent a \$1,000 check to the City to plant trees on Woodsprings Road clover leaf.

He commended the Street, 911 and Sanitation Departments for their work during the recent snow storm. He stated they met on Monday to formulate a plan to work on main arteries first, then work on secondary roads.
