Councilman Gibson offered the ordinance for first reading by title only.

Mayor Perrin explained a lot of cities have consultants stationed in Washington D.C. to help them get more federal grants through potential projects, as well as assisting to coordinate with congressional delegation concerning grants. He stated Jonesboro representatives cannot be in D.C. all the time and only go once or twice a year to work with agencies to receive funding. Grant funding allows the city to do projects that could not be financed with sales tax dollars alone. Mayor Perrin further explained they will be venturing out into the private sector to receive grant funding. They already have meetings scheduled during a Washington trip they will be taking later this month to discuss grant funding with several private companies. The consultant's contract will have a clause in it allowing the city to get out of the contract if they see fit. The consultant they are looking at is experienced and they think he will be able to get the city a lot of added funding. Monthly reports will be provided by the consultant to ensure work is being done on the city's behalf. Mayor Perrin added they expect about three to four times the consultant's salary to be brought in via grant funding.

Councilman Moore asked about the emergency clause. Mayor Perrin explained they added the clause because they have a Washington D.C. fly-in on April 22 and have some meetings scheduled. It would be good to have the contract in place before April 22nd.

Mr. Phillip Cook asked about the proposed contract. Mayor Perrin stated the contract will cost about \$3,000 per month.

Mr. Robert Coleman questioned who the consultant is they are looking at. Mayor Perrin explained the individual lives in Washington D.C. They have known him for at least five years and used to work with Senator Boozman. He is currently representing several cities in this area. Mr. Coleman expressed concern about working with someone from Washington due to the state of the federal government. Mayor Perrin stated a city cannot be run on sales tax alone. Jonesboro currently has between \$18

million to \$20 million in grant funding that came from several agencies such as HUD, Department of Justice and the Department of Transportation. Those funds are needed in order to provide the citizens with needed services. Mr. Coleman stated he would like to know the authorities this person will have. City Attorney Carol Duncan explained the consultant will have no authority on behalf of the city. She reiterated the contract has a 30-day out clause in case the city becomes unhappy with the services they can cancel the contract.

Councilman Burton stated he is anxious to see the grants the city is able to obtain through private funding. Mayor Perrin agreed.

8. MAYOR'S REPORTS

Mayor Perrin reported on the following items:

The property maintenance code is continuing to be looked at. Councilman Moore recently visited with him, City Attorney Duncan, Lt. Todd Nelson from Quality of Life and Chief Building Official Tim Renshaw concerning the code. Once the code is finalized they will be presenting it to the Council for adoption.

The recycling program was advertised. There was one bidder, Abilities Unlimited. They are working with the company for a contract to present to the Council.

The Wolverine demolition is scheduled for April 21st. The bids came in well. It will include the two buildings and the entire slab.

He along with Grants Administrator Heather Clark and Chief Financial Officer Ben Barylske will be flying to Washington D.C. on April 22nd. Meetings have been scheduled with several private companies, as well as government agencies.

Fisher & Arnold has completed their plan for Northside Park. A map was located in Council Chambers during the meeting for viewing. There will be an area for community gardening. There will also be a connector between Highway 141 and Patrick Street. They are going to try and get grants to pay for the park, which is estimated at \$4.8 million.

They are still working on the Citizen's Bank building. The state has taken it back and will be sold in May. There are some companies who are interested in purchasing the building.

9. CITY COUNCIL REPORTS

Councilman Woods asked for an update on the grants program. Mayor Perrin stated Ms. Clark will have a report to present at the next Council meeting.

Councilman Burton stated he is glad to hear things are moving forward with the property maintenance code as recommended by the Moratorium Committee. He then asked about the roundabout project. Mr. Light explained it is a city-initiated project with state funds being used to fund it. A study of the intersection showed there was only one hour in the day when a traffic light would help the flow of traffic with the rest of the hours a light would delay traffic. There won't be near as many delays with a roundabout intersection. Councilman Burton questioned whether there will be any conversations with the schools about ways to get cars out of the roadways during peak travel times so it doesn't affect the traffic flow at the roundabout. Mr. Light explained that's not really a problem with the intersection; rather it's a problem with getting traffic to flow at the school so it doesn't hold up traffic on the road. That may be another project that needs to occur after conversations with the school. He added if the traffic does back up into the intersection it would be caused because of the turn

into the school, not the intersection design. Councilman Burton then asked if there will be any educational plans to inform people about the roundabout. He asked if something could be put on Channel 24 to help people drive in the new intersection. Director of Communications Fritz Gisler stated he went through the exact same process in Fayetteville and they will be working together to put educational materials together for Channel 24 and get some things in print.

Councilman Gibson stated he has been reflecting on Councilman Moore's comments at a past Council meeting where concern was expressed regarding the number of walk-ons to the Council agenda. He asked for City Clerk Jackson to send all the Council members a copy of the current Council procedures for review. He would like their feedback as whether or not they think they need a refresher course on the Council procedures. Mayor Perrin added he has asked Mr. Gisler to look at the Council's rules and procedures to see if there's anything the administration should change.

Councilwoman Williams stated she is glad to see the sidewalk projects that will be done in 2015. She's received questions from citizens regarding some of the projects, so they'll be happy to see the projects being undertaken.

Councilman Moore asked for a presentation concerning the Land Use Plan and the Master Street Plan at the next Council meeting. He asked that a department head do a short presentation highlighting the differences between the current plans and the proposed changes. Mayor Perrin answered yes, they'll do a presentation on both plans. It was noted Mr. Spriggs will not be present at the next meeting, so he will do the presentation at the following meeting.

Councilman Moore then referred to comments made earlier by Mr. Light concerning traffic backing up to intersections. Councilman Moore stated there is a problem with traffic backing up at the Flint and Nettleton lights due to children waiting to unload/load at the Kindergarten Center. He asked for that intersection to be looked at so, if needed, they could possibly asked Jonesboro Public Schools to deed some property to the city to make extra turning area for cars to unload/load the kids. He's noticed the traffic backs up and you can't get through the intersection.

10. PUBLIC COMMENTS

Mr. Mike Regan, an ASU student, asked the Council to pass a resolution protecting its employees from discrimination due to sexual orientation or gender identity. He explained he wants Jonesboro to be viewed as a welcoming environment. He stated he has had trouble in Jonesboro and has sent applications to other schools due to the troubles he has had. He further explained he was assaulted recently at IHOP due to his presumed sexual orientation. He feels it's important for non-discrimination to be in place to protect any city and state employees.

Ms. Amber Carswell, 904 West Oak Avenue, also spoke in support of the Council passing a resolution protecting city employees from discrimination due to sexual orientation or sexual identity. She spoke on behalf of a downtown business owner and said she didn't want to see the city participate in discriminatory practices. But, she would also like to see protections in place. Ms. Carswell asked the Council to do what's right and to address the disease of bigotry and contempt for humans on a deeper level.

Ms. Lealea Van Winkle Gisler stated she is new to Jonesboro. She came from a

community that was ripped apart by this issue, but has found Jonesboro to be welcoming and encouraging to her and her husband. She explained everyone has strong values and beliefs. She asked that respect be shown to the people in this process. She added no one is a villain and no one needs to be vilified because of what they believe. Ms. Gisler further added this is an amazing city, but if we vilify each other and don't listen then progress will go backwards. She then asked that nothing be rushed into. She asked that if the Council decides to act on this matter that it be done in a reasonable and considerate manner. Ms. Gisler explained in Fayetteville they tried to push through an ordinance that was ill-conceived and just made things worse and it caused people to be pulled apart. She asked that the Council respect each other, listen and continue to move the city forward.

Another citizen spoke in favor of adopting a resolution. She explained she is from Jonesboro, she lives here, her family is here and her business is here. She pays her state taxes every month and is held to the same standard as every business owner here. But, she is not afforded the same civil protections. If she is going to continue to be held to the same expectations, she should also receive the same civil protections.

Ms. Keira Hazelwood stated this issue is not about somebody's beliefs; rather, it is about the citizens. All citizens have the same right to be protected under the same civil ordinances. She added this is not an endorsement of a religious belief to protect all of the citizens. We all deserve the same protection and every human should be given the same protection under the law.

Councilwoman Williams explained this issue has to do with the city employees and the employee handbook, so it should be referred to the Finance Committee.

Councilwoman Williams motioned that the issue be referred to the Finance Committee. The motion died for lack of a second.
