WHEREAS, Dr. Bill Bowers ask the City Planning Committee to approve rezoning a tract of real estate Classification C-5 described as follows:

.76 of an acre lying along and joining Arkansas Highway
#39 including the residence and office of Dr. Bowers
and lying north of the next described tract.

and the following described tract of real estate from Classification R-1 to R-2:

.71 of an acre at the intersection of Arkansas Highway
#39 and the Highway #63 Bypass.

WHEREAS, the City Planning Committee voted to recommend rezoning of these two tracts of real estate to the City Council.

WHEREAS, Dr. Bowers has made known his intentions of presenting the matter of rezoning to the City Council for the Council's approval.

WHEREAS, the undersigned voters and residents of Marlo Acres, Melton and adjoining addition of the Fifth Ward of the City are strongly opposed to the rezoning of the last described tract of real estate from Classification R-1 to R-2 or any other Classification than R-1, and
