A RESOLUTION OF THE CITY OF JONESBORO, ARKANSAS TO ENTER INTO AN AGREEMENT WITH THE ARKANSAS DEPARTMENT OF TRANSPORTATION (ARDOT) FOR MODIFICATION TO THE CITY OF JONESBORO RAIL CROSSING (DOT #917584G) AT HWY. 18 SPUR MARTIN LUTHER KING JR. DRIVE WIDENING PROJECT (JOB 100657)

WHEREAS, the Arkansas Department of Transportation (ARDOT) is preparing plans to widen Hwy. 18 Spur Martin Luther King Jr. (MLK) Drive to five lanes; and,

WHEREAS, this roadway widening project will require modifications to the city-owned at-grad railroad crossing (DOT #917584G) along MLK Drive; and,

WHEREAS, ARDOT agrees to reimburse the City of Jonesboro for all expenses and actual costs incurred for this rail modification work; and,

WHEREAS, an agreement for reimbursement of Preliminary Engineering (PE) services related to this rail modification is attached; and,

WHEREAS, Supplemental Agreements for engineering design and construction related services are expected.

NOW, THEREFORE BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS;

Section 1. That the City of Jonesboro agrees to collaborate with ARDOT and modify the City of Jonesboro rail crossing at Hwy. 18 Spur (DOT #917584G) Martin Luther King Jr. Drive to accommodate the five lane roadway project.

Section 2. The City of Jonesboro shall be reimbursed by ARDOT for all expenses and actual costs incurred for this project in accordance with the attached PE Agreement and any other Supplemental Agreements.

Section 3. The Mayor and the City Clerk are hereby authorized by the City Council for the City of Jonesboro to execute all documents necessary to effectuate this PE Agreement, and any Supplemental Agreements to facilitate this work.

Dear Mayor Copenhaver:

Plans are being prepared for State Job 100657 which will widen the City of Jonesboro crossing DOT# 917584G to five lanes at the referenced location. In connection with the project, ARDOT (Agency) considers it necessary for the successful advancement of the project for the City to collaborate in the development of the project by performing the following:

- preliminary engineering and other related services
- development of cost estimates for railroad track force account work including installation of drainage under track
- review of the project's preliminary layouts
- provide current train activity at this crossing

The Agency authorizes and agrees to reimburse the City for its expenses and actual costs that are incurred for collaborating in the development of the project's preliminary engineering and other preliminary activities. The City has allowance of preliminary engineering cost of no more than \$25,000. Payment will be made within thirty (30) days from the Agency's receipt and approval of the City's request for reimbursement. The City will refer to Agency's Project Number 100657 and forward invoices to Steve Frisbee, P.E., TPP Division Engineer, Transportation Planning and Policy Division, Arkansas Department of Transportation, P.O. Box 2261, Little Rock, AR 72203.

Please indicate the current train activity occurring at this crossing: _____

The project may require the City to incur costs for force account activities at construction. Please be prepared to provide the force account cost estimate for work activities once these Preliminary Engineering activities are complete and submit them to ARDOT at your earliest convenience. These plans and estimates will be attached to the ARDOT generated Construction & Maintenance (C&M) Agreement that will be prepared for this construction activity.

This agreement is intended to address Preliminary Engineering only. It is understood that ARDOT may cancel for any reason necessary. If the project is approved to move to construction activities, the City will continue to work with the Agency to develop Final Plans, Specifications and prepare Material and Cost Estimates for Railroad Construction Work associated with the project. It is also understood that if the project is constructed, work cannot begin until the C&M Agreement is fully executed and the ARDOT Work Order is issued to the City. After performing the work under each project notice, the City, at its sole expense, shall maintain the facilities which have been constructed or adjusted under this agreement.
