Presentation by City Engineer Craig Light concerning Talley property flooding at 318 Leslie Ann

Mr. Light explained there are a couple of culverts that move the water away from the property and takes it to a tributary of Turtle Creek. He added they had an outside engineering firm come up with different ideas on how to fix the problem. He further explained that alternative 2 was the recommendation that was picked and it would provide a 25 year level of protection to the property at a cost of \$18,250.

He then discussed the questions that had been previously asked by the Council.

He added this property is part of the Meadow Lark Acres Extended Subdivision that was platted in 1968 and annexed into the city in 1988. The streets were built pre-annexation and he is unaware of any road work that has been done since it was annexed into the city. He added the house was built between 1978 and 1980 based aerial photos and no record of a permit being obtained to build the house has been found, but the house was in the county when it was built.

Councilman Moore inquired about the drainage easement on 318 Leslie Ann that alternative 2 is requiring. Mr. Light stated if the owners would grant the city an easement the cost of the project would be lower. Councilman Moore explained he does not think the city should have to purchase an easement to fix a problem that wasn't caused by the city.

Councilman Vance asked how this property would be classified. Mr. Light answered it is a minor crossing, but the city could make the culverts for a 25 year event under alternative 2. He noted the city has been unable to find any projects that contributed to the flooding of the property.

Chairman Street asked if Mr. Light thinks if the city contributed to the flooding problem on the property. Mr. Light answered no, but the city has tried to fix the flooding problem.

Councilman Vance questioned if alternative 2 will fix the majority of the problem. Mr. Light answered it will bring the property up to a 25 year event, but there could be larger storms where it could still flood. He added the city has recommended to the property owners that they purchase flood insurance.

Councilman Dover asked if a pipe that is installed in the easement would be for a 100 year event. Mr. Light answered if it is a minor street crossing then the culvert is for a 10 year event.

Chairman Street inquired if Mr. Light recommends alternative 2. Mr. Light answered yes and the city has offered to do this with the property owners.

Councilman Vance asked if the project would cost approximately \$10,000 if the easement is donated. Mr. Light answered yes.

Councilman Moore inquired if the project would help the rest of the neighborhood. Mr. Light answered it would help the property adjacent to the south.

Mr. Jeremy Talley, 318 Leslie Ann, explained his house has flooded several times over a few years. He added he has to remove the rocks that were installed in the ditch because they hinder the flow of the water. He noted dirt on the adjacent lot was brought in by a family member of the owner of that property and it changed the flow of the water. He stated the house floods even though the culverts are half full. He added his property deed shows the property being annexed into the city in 1978 and the house was built in 1980.

Councilman Dover asked if there is a reason why the culvert is not getting full. Mr. Light answered that is the reason why the city is recommending the pipes be extended south to the property line and a box be placed in the back to catch the water quicker.

Councilman Moore motioned, seconded by Councilman Vance, to Recommend to Council that the City adopted the City Engineer's recommendation of alternative 2 as long as the property owners grant an easement. All voted aye.
