#### 4. Special Presentations

##### Presentation of the Jonesboro Police Department's Life Saving Medal of Honor

*Mayor Perrin discussed a recent event where Ms. Stacey Stockdale found her 2-year-old son, Grant, unresponsive in the family pool. Grant's 8-year-old brother, Donovan, quickly called 911 for help. He further explained 911 Operator Charles Jones instructed Ms. Stockdale how to give CPR to Grant, while Police Officers Keri Varner and Jo Carter and responders from Fire Engine #5 arrived on the scene. Fire Battalion Chief Brett Winstead and Ms. Stockdale continued to administer CPR and were able to revive Grant. Mayor Perrin stated Grant was flown to Memphis for medical attention. He then asked Police Chief Michael Yates to present Police Officer Keri Varner, Fire Battalion Chief Brett Winstead, 911 Operator Charles Jones, Stacey Stockdale, and Donovan Stockdale with the Life Saving Medal of Honor. Mayor Perrin noted Donovan Stockdale is a baseball and Parks Department Director Jason Wilkie presented Donovan with an autographed baseball bat signed by Major League Baseball player and member of the Baseball Hall of Fame, George Kell. Mayor Perrin also presented Donovan with a special proclamation from the Jonesboro Baseball Booster Club.*

## **8. Mayor's Reports**

**COM-09:093**     Financial report as provided to the City Council at the meeting on August 4, 2009, by Finance Director Jim Barksdale.

*Mr. Barksdale stated the month end process went smoothly and discussed the revenues, expenditures and changes in fund balances through July. Councilman Dover questioned how much of the deficit spending was due to the lease payment. Mr. Barksdale answered \$2.8 million. He also noted there were some other fixed assets purchases in January. Mayor Perrin also stated they are still waiting to receive reimbursement money from FEMA, which could total \$1.5 million to \$2 million.*

**This item was Read.**

*Mayor Perrin stated he attended the CALEA exit interview for the Police Department. He explained the committee will be recommending CALEA certification for the Jonesboro Police Department, but it may be October or November before the Department knows anything. He added he also attended an Executive Committee meeting from the Arkansas Municipal League. He stated he sent out letters to the mayors of the ten largest cities in the State inviting them to a round table meeting in Jonesboro on September 25 and September 26.*

*Mayor Perrin explained the Corps of Engineers has asked him to make a presentation concerning the City's 300 miles of ditches. He stated he has received a cancellation from the Highway Department concerning a stoplight at Highway 63 and Southwest Drive. He also noted they are putting a hold on the Highway 63 and 351 signalization due to working with the railroad in order to acquire some property.*

*Mayor Perrin then discussed the fire station grant and stated our national delegations are supporting the City. He also discussed the old tornado sirens. He stated he has already received letters from surrounding cities who are interested in utilizing the old sirens.*

*Mayor Perrin explained they will be holding public hearings regarding the Master Land Use Plan. He further explained a control light will be going up on Stadium and a double left hand turn lane will be made on Windover and Highway 1B. He added they have met with a private company concerning a compost facility and are also still working with Legacy Landfill.*

*He then noted the Revenue Enhancement Committee should have a proposal in September for the City Council to review. He stated some fees haven't been increased since the 1970s and there are also some things the City is not charging for that the committee is looking at.*

He also stated the City Engineer and Contract Manager will review all City contracts and sign off on them before being presented to the Mayor and City Clerk for signing. He informed the Council they have sent out RFPs for actuarial services and asset management of the non-uniform pension plan. He added they have a draft of the real estate book showing City-owned property and anticipate presenting that to Council soon.

Mayor Perrin commended Grants Administrator Tony Thomas for his work in collecting grant money for the City amounting to \$14.9 million. He also stated the Mayor of Marmaduke has indicated he will be reimbursing the City for money spent during the aftermath of the tornado in which the City went through a lot of vehicle tires.

## **9. City Council Reports**

Councilman Street congratulated Police Chief Michael Yates for their CALEA recommendation and for receiving a \$1 million grant that will fund the hiring of new officers.

Councilman Dover commended the Mayor and Finance Department for having month end reports so quickly after the end of July.

Councilman McCall gave an update concerning the sesquicentennial, noting there will be some announcements in the next ten days.

Councilman Gibson motioned, seconded by Councilman Moore, to suspend the rules and add a resolution to the agenda. All voted aye.
