ORDER OF ANNEXATION

That said petition is signed by the owners of the lands hereinafter described; that the petitioners own all of the acreage hereinafter described; that the notice of the filing of said petition and the date, time and place of hearing upon said petition has been duly given and published as required by law; that all things required by law to be done have been duly and properly done; that the allegations of the petition are sustained by proof; that the requirements for signatures have been duly complied with; that the limits of the territory and lands to be annexed have been accurately described; and
