




COMMENCE AT THE SOUTHEAST CORNER OF LOT 8 OF BLOCK "A" OF SUNNY ACRES SUBDIVISION TO THE CITY OF JONESBORO, CRAIGHEAD COUNTY, ARKANSAS: THENCE NORTH 88°46'28" WEST ALONG THE SOUTH LINE OF LOT 8 OF BLOCK "A" AFORESAID, 5.00 FEET TO THE POINT OF BEGINNING: THENCE CONTINUE NORTH 88"46"28" WEST ALONG SAID SOUTH LINE 50,00 FEET TO THE ARC OF A CURVE CONCAVE WESTERLY WITH A RADIUS OF 50,00 FEET AND WHOSE RADIUS POINT BEARS NORTH 88'46'28" WEST: THENCE ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF IT'27'27" A DISTANCE OF 1523 FEET: THENCE SOUTH 88'46'28" EAST PARALLEL WITH THE SOUTH LINE OF LOT 8 OF BLOCK "A" AFORESAID, 37.97 FEET: THENCE NORTH 03*52'00" EAST PARALLEL WITH THE EAST LINE OF LOT 8 OF BLOCK "A" AFORESAID, 315.69 FEET TO A POINT ON THE NORTH LINE OF LOT 8 OF BLOCK 'A" AFORESAID: THENCE NORTH 89"58"00" EAST ALONG SAID NORTH LINE 15.03 FEET: THENCE SOUTH 03"52"00" WEST PARALLEL WITH THE EAST LINE OF LOT 8 OF BLOCK "A" AFORESAID, 33104 FEET TO THE POINT OF BEGINNING.


