ORDER OF  
CONFIRMATION OF ANNEXATION

On this 10<sup>th</sup> day of October, 1986, comes on for hearing before the Court the above-styled cause and matter now appearing for the approval and confirmation of the annexation of said lands heretofore dated September 10<sup>th</sup>, 1986. The Petitioners appear by and through their attorneys, Lyons & Emerson. The matters upon pleadings and orders with exhibits thereto filed herein, the certificate of the Circuit Court Clerk of Craighead County, Arkansas, certifying that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County to prevent the annexation of said lands and territory herein, from all of which together with other things and matters before the Court, the Court doth find:

1. That said lands herein are annexed to the City of Jonesboro by order of this Court dated September 10<sup>th</sup>, 1986, and that no proceedings have been filed in the Circuit Court for the Jonesboro District of Craighead County, Arkansas, to prevent such annexation within thirty (30) days from the date of said order and annexation, and that said annexation was in all things done in conforming with the laws and statutes of the State of Arkansas, and should therefore be approved and confirmed; that said territory should be accepted by the City of Jonesboro, Arkansas; that the lands and territories annexed to the City of Jonesboro, Arkansas, are described as follows, to wit:


Part of the Southeast Quarter of the Northwest Quarter and part of the Southwest Quarter of the Northeast Quarter of Section 5, Township 13 North, Range 4 East, which is described as follows: Commence at the Southwest corner of the Southwest Quarter of the Northeast Quarter of Section 5

aforesaid, thence North to the North line of a county road approximately 30 feet to the point of beginning proper, thence run East along the North right of way line of the county road approximately 229.4 feet to the West line of State Highway No. 1, thence run North a distance of 738.8 feet along the West right of way line of State Highway No. 1, thence run West parallel to the Southern boundary of this property a distance of approximately 352 feet to the Eastern edge of the Craighills Golf Course, thence run South parallel to the quarter section line to a point which is 200 feet from the centerline of the county road, thence run East to the quarter section line, thence South to the point of beginning proper.

IT IS, THEREFORE, BY THE COURT, CONSIDERED, ORDERED and ADJUDGED that the annexation of said lands and territory herein to the City of Jonesboro, Arkansas, be and in all things approved and confirmed, and that the proceedings before this Court be and are hereby confirmed. The Clerk of this Court be and is hereby authorized and directed to certify one (1) copy of the plat of such annexed territory with one (1) copy of this order of this County Court and resolution or ordinance of the City of Jonesboro, Arkansas, and forward a copy of each to the Secretary of State who shall file and preserve the same and shall forward one (1) copy of the plat of said annexed territory and one (1) copy of this order to the Director of Tax Division of the Arkansas Public Service Commission who shall file and preserve the same and shall notify all utility companies having property in said municipality of this annexation of property, and the Clerk is directed to forward a certified copy of this order to the City Clerk's office of the City of Jonesboro, Arkansas.
