A 4 acre square in the Northwest corner of the NW $\frac{1}{4}$ NE $\frac{1}{4}$, 38 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ and 1.5 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ all in Section 26-Township 14 North-Range 4 East, being more particularly described as follows: Begin at the Southeast corner of Veon Keich Addition to the City of Jonesboro, Arkansas; thence North to the North line of Section 26-Township 14 North-Range 4 East; thence East to the Northeast corner of said NE $\frac{1}{4}$ NW $\frac{1}{4}$; thence East 417.5'; thence South 417.5'; thence West 417.5' to the East line of said NE $\frac{1}{4}$ NW $\frac{1}{4}$; thence South along said line to the Southeast corner of said NE $\frac{1}{4}$ NW $\frac{1}{4}$; thence West to the Southwest corner of the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 26; thence North on the 40 acre line to the North right of way line of the St. Louis and S.F. Railroad; thence East along said right of way line to the West line of the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 26; thence North along said line to the South line of Veon Keich Addition; thence East to the Southeast corner of Veon Keich Addition, the point of beginning, containing 43.5 acres, more or less.
