A PARCEL OF LAND LYING WITHIN THE NORTHWEST QUARTER OF SECTION 5, TOWNSHIP 13 NORTH, RANGE 4 EAST, CRAIGHEAD COUNTY, ARKANSAS, SAID PARCEL INCLUDING A A PORTION OF LOT 1, BLOCK C OF THE REPLAT OF CRAIGHILLS THIRD ADDITION, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

A DISTANCE OF 55,51 FEET TO THE POINT OF TANGENCY OF SAID CURVE; THENCE NORTH 18°57'08" EAST, CONTINUING ALONG THE EASTERLY LINE OF SAID LOT 2-1R, A DISTANCE OF 94.14 FEET TO THE POINT OF CURVATURE OF A CURVE CONCAVE TO THE WEST, HAVING A RADIUS OF 230.00 FEET, A CENTRAL ANGLE OF 18°42'35", A CHORD BEARING OF NORTH 10°19'15" EAST AND A CHORD DISTANCE OF 69.03 FEET: THENCE NORTHERLY.
