Discusson concerning committee business

Councilman Frierson stated he recently spoke with Parks Director Wixson Huffstetler. Mr. Huffstetler suggested that due to the small amount of items that are taken to the committee, to merge their business with other committee's such as the Finance Committee. It was suggested that items that have to do with money, such as signage contracts, should be taken to Finance instead of Public Services. That way the Public Services Committee would only meet to discuss public service items, not necessarily money items. Councilman Frierson explained he agreed with Mr. Huffstetler and spoke with Mayor Perrin about it. Mayor Perrin stated to him that he did not want to disband the Public Services Committee, but would agree with sending some of the items to other committees. JETS Director Steve Ewart added that he thinks it's a good idea to have a committee that covers public service. Councilman Frierson explained he is not in favor of disbanding the committee; rather, he thinks some item could be taken to other committees to save time. Councilwoman Williams agreed. Chairman Gibson also agreed, noting that in this particular meeting there was only one item of business, yet three committee members had to attend the meeting and someone from the Clerk's Office had to be there to do the minutes. He then questioned if the committee needs to do anything regarding this matter. Councilman Frierson stated the Mayor indicated he would meet with the appropriate people to discuss the committee and what the committee will cover in the future, so he doesn't think the committee needs to take any action until after the Mayor can come to a decision. It was added that after that the committee will start meeting on an as needed basis.
