A RESOLUTION TO THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS AUTHORIZING THE MAYOR AND CITY CLERK TO GRANT A (PERMANENT EASEMENT) LOCATED AT 1614 STRAWFLOOR DRIVE, JONESBORO, ARKANSAS FOR THE PURPOSE OF INGRESS/EGRESS PRIVILEGES


WHEREAS, Doyle Brown and Margaret Brown have transferred (by gift deed) property to the City of Jonesboro, Arkansas. The property more particularly described as follows:

A part of the West ½ of the SW ¼ of Section 23, Township 14 North, Range 3 East, Craighead County, Arkansas. Also known as 1614 Strawfloor Drive.

WHEREAS, there is a need to cross the described property to service radio towers; Doyle Brown and Margaret Brown request Ingress/Egress privileges.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF JONESBORO, ARKANSAS THAT:

Section 1: The Mayor and City Clerk are hereby authorized to execute the documents necessary to complete this transaction.

PERMANENT EASEMENT

KNOW ALL MEN BY THESE PRESENTS:

For good and valuable consideration acknowledged to be of value by the Grantors, receipt of which is hereby acknowledged, the undersigned GRANTOR CITY OF JONESBORO do hereby grant, convey and release unto DOYLE BROWN AND MARGARET BROWN, HUSBAND AND WIFE and unto their successors and assigns, an easement and right of entry in, over and across the following described land situated in the City of Jonesboro, County of Craighead, State of Arkansas, to-wit:

A part of the West $\frac{1}{2}$ of the SW $\frac{1}{4}$ of Section 23, Township 14 North, Range 3 East, Craighead County, Arkansas, being more particularly described as follows:

Beginning at the Southeast Corner of the Southwest Quarter of the Southwest Quarter of Section 23, Township 14 North, Range 3 East; thence South $89^{\circ}14'46''$ West, 198.00 feet to the point of beginning proper; thence South $9^{\circ}19'15''$ West 478.16 feet; thence North $00^{\circ}36'35''$ West 656.84 feet; thence South $89^{\circ}28'08''$ West 224.69 feet; thence North $00^{\circ}04'57''$ East 239.89 feet; thence North $89^{\circ}37'23''$ East 97.42 feet; thence South $00^{\circ}22'37''$ East 113.80 feet to a point on a curve to the left; thence Southeasterly along said curve, with a central angle of $156^{\circ}32'28''$ a radius of 15.00 feet, 40.98 feet to a point which bears South $78^{\circ}38'51''$ East 29.37 feet from the last said point; thence North $23^{\circ}04'55''$ east, 199.02 feet; thence North $77^{\circ}16'30''$ East 257.04 feet to a point on a curve to the left; thence Northwesterly along said curve, with a central angle of $235^{\circ}59'52''$, a radius of 15 feet, 61.78 feet to a point which bears North $40^{\circ}43'26''$ West, 26.49 feet from the last said point; thence North $79^{\circ}49'14''$ West 3.31 feet; thence North $13^{\circ}54'47''$ East 82.54 feet; thence South $88^{\circ}42'34''$ East 229.86 feet; thence South $01^{\circ}16'37''$ East, 1105.59 feet to the point of beginning proper, containing 12.48 acres, more or less subject to all rights of way and easements of record

This easement includes the right of ingress and egress over and upon

the above described land of the grantors.

TO HAVE AND TO HOLD the aforesaid easement in, over and upon the above described land of the Grantors, with all the rights, privileges and appurtenances thereunto belonging or in any wise appertaining, unto the Grantee, its successors and assigns forever.
