Discussion concerning the sex offender registration position in the Police Department

Police Chief Rick Elliott explained they accepted applications, did interviews and have selected an applicant that will be suitable for the position. They selected Mr. Tony Williams, a retired Paragould Police Department Lieutenant. Mr. Williams dealt with sex offenders during his tenure at the Paragould Police Department, so he has a working knowledge these types of situations. They expect Mr. Williams to start work on May 1st.

Councilman Moore asked if Mr. Williams will keep his certification in case he's needed in another aspect. Chief Elliott answered no, because Mr. Williams is retired. They could bring him into the department if needed, but a large part of this position is administrative. If Mr. Williams does have to go out into the public to perform his work he will have an officer accompany him. Chief Elliott stated he thinks Mr. Williams will be a big asset to the department since they will not have to do as much training since he's already familiar with procedures.

Councilman Vance then questioned whether an officer's slot was eliminated when the sex offender registration position was taken over by a civilian. Chief Elliott answered yes because the officer was handling a lot of duties, which is why they decided to add a civilian position to take care of sex offender registration so the officer could be freed up to perform official duties.

Councilman Moore asked if it was the Mayor's recommendation to hire Mr. Williams. Mayor Perrin answered yes.

Councilman Moore motioned, seconded by Councilman Vance, to affirm the decision to hire Mr. Williams. All voted aye.
