Parks Director Wixson Huffstetler discussed the resolution. He explained Lakeside was the low bidder. It was lower than expected. Lakeside has done other work on the greenway. It will be a ten month project that will start at Matthews Avenue by the Mall at Turtle Creek and go to Matthews and Main Street. He noted they will actually start the work at Matthews and Main and work backwards. There will be about 200 trees planted. Some traffic may be hectic because a lane of traffic will have to be shut down during the project. He added St. Bernard's Hospital is happy about the

shutdown because they are hoping it will slow traffic down around the hospital.

Councilwoman Williams asked what the next portion of the greenway will be. Mr. Huffstetler stated that on the master plan the next leg will be from Matthews and Main to Joe Mack Campbell Park. There is \$2.1 million in grant funding, so they have decided to ask the Highway Department for permission to allocate those funds to build a walking trail inside the road at Craighead Forest Park. That project will cost about \$2 million.

Further discussion was held concerning the greenway. Mr. Huffstetler explained there has been some talk of making the greenway trail go from Joe Mack Campbell Park to Bono Lake via the power lines and over the ridge. Councilwoman Williams questioned whether they can get updated plans of the greenway. Mr. Huffstetler indicated the Engineering Department has already made updated maps available to the public.
