Begin at the corner of Lots 23 & 24 at the intersection with the Northerly R/W line of Ridgecrest Drive in said Addition; thence S44°13′05"W along said R/W line 13.12′ to the proposed easement line, the point of beginning proper; thence S44°13′05"W along said R/W line 15.68′ to the proposed easement line; thence with the meanderings of said easement line as follows; N28°53′30"W-40.21′; N24°35′18"W-68.36′; N17°47′43"W-21.14′ to the P.C. of an easement curve left whose radius = 85.00′; thence Northwesterly along said easement curve 57.20′ to a lot line; thence North on said lot line 16.50′ to a proposed easement line, said point being on a curve right whose radius = 100.00′; thence Southeasterly along said easement curve 74.76′ to the P.T. of said curve; thence with the meanderings of said easement line as follows; S17°47′43"E-21.14′; S24°35′18"E-67.79′; S28°53′30"E-35.09′ to the point of beginning proper, containing 2891 square feet, more or less, subject to all rights of way and easements of record
