

RIGHT-OF-WAY DEED

KNOW ALL MEN BY THESE PRESENTS:

That we, Johnnie Pieri and Stella Piera, his wife, Louise Pieri (sole devisee of Julius Pieri, deceased), Albert Pieri and Mary Pieri, his wife, Louise White Goodman, Tony Pieri, a single person, and Annie Pieri, for and in consideration of the benefits to be conferred upon us, do grant, bargain, sell and convey unto the City of Jonesboro, Arkansas, a municipal corporation, all of our right, title and interest in and to a strip of land 30 feet from the centerline of Main Street along Lots 6, 7, 8 and 9 and a 41 foot strip of land from the centerline of Church Street along Lots 2, 3 and 4 all in Pieri Addition to the City of Jonesboro, Arkansas, a Plat of said addition being recorded in Deed Record 123, page 120 in Jonesboro. (14-4-75)

To have and to hold unto the City of Jonesboro and the public generally forever.

And Stella Pieri, wife of Johnnie Pieri, Mary Pieri, wife of Albert Pieri, for the consideration aforesaid release unto the City of Jonesboro, Arkansas, all of our right or possibility of dower and homestead to the strip of lands above described.
