Parks Director Jason Wilkie discussed the Greenway Project. He stated there has been some concern expressed relating to the Allen Park area. He explained the greenway will not be lighted because it's expensive and because they did not want to add a perception of safety. He added there are portions of the greenway they could look at lighting due to nearby light poles. He stated they are hoping to connect the greenway to ASU as quickly as possible so the students can use the greenway. Councilman Hargis questioned whether any surveillance would be done on the greenway between the mall and Allen Park. Mr. Wilkie stated Police Chief Yates indicated they cannot do much more than what they are currently doing without adding additional staff. He noted he and Mayor Formon have discussed the police motorcycles periodically driving down the greenway to provide some presence. Councilwoman Furr questioned whether the advisory committee spoke with the homeowners who will be living adjacent to the greenway. Mr. Wilkie stated the advisory committee did not speak with homeowners in the area. Councilwoman Furr then questioned if there are a lot of homeowners in that area who would be affected by the greenway. Mr. Wilkie stated this particular area would have the least amount of homeowners adjacent to the greenway. Councilwoman Furr asked whether they planned on having some sort of public hearing so people can discuss the greenway, particularly the residents who will be living adjacent to it. Mr. Wilkie stated he didn't have a problem with going to the Fairview Addition area and having a public meeting to discuss the greenway.

8. Mayor's Reports

Main Street pond update

Mr. Wilkie stated they have drained the pond. He added the coy fish are currently in a pond in the Clopton Clinic. He explained they are preparing a scope of work to make the pond constructed better for public use. He noted the some downtown merchants have offered to help find private donors. Councilman McCall stated he thought the City was not involved with the pond. He added he has been told some money was given by the City to help with the pond. Mr. Wilkie stated he did not know about that. Councilman Province stated he was on a Parking Committee that rejected the proposal for the pond. He explained he was told there was a state grant that became available for \$5,000 to help build the pond. Mayor Formon and Mr. Wilkie stated they did not know of any grants that became available for the pond. Councilman Province stated he thinks the grant became available not long after Mayor Formon came in office and the grant included other things like lighting. Mr. Wilkie stated it's their goal to get private donations and to make it require less maintenance.

Willows Apartments update

Public Works Erick Woodruff discussed the emergency condemnation at the Willows. He explained the owner has been notified and will be given 30 to bring the buildings in question up to code or the complete condemnation process will start. He noted the owner is a resident of Colorado. He further explained there were 5 families and they assisted in helping find them places to live. Councilman Province questioned how the buildings got so bad before something was done. Police Chief Yates stated the condemnation ordinance has been changed to allow the City to condemn more properties. Mayor Formon stated the owner had indicated to him in June that he would send the Mayor's Office a letter detailing what improvements would be made, but the letter had not been received. Councilman Moore stated they will be having a walk-through inspection of the remaining buildings on Friday which might affect up to 48 renters.
