Councilmember Dr. Anthony Coleman said, I do understand bidding but my question is, has anyone spoken to any of the actual rail users about this? Engineering Department Director Craig Light approached the podium and said, this is the contract to do the inspections and maintenance on the city owned railroad track out in industrial park. Shelby Railroad has had this contract for at least the last two years and I think they did it a couple years before that. So, this is just a continuation of an on-going agreement with Shelby. We just decided to re-bid it to get the prices to current market value prices. Councilmember Dr. Anthony Coleman said, my point was, I did get a call

from a rail user about it and they just wanted to make sure that we did have open communication with those rail users to make sure that they understand. That's why I asked. Director Craig Light said, yeah, we have meetings periodically with the rail users group with the Chamber of Commerce, so we have all their contact information. I'm not sure who reached out to you, but we do have communications with each one of the factors and the users the railroad spurs. Councilmember Dr. Anthony Coleman said, I can share that with you. Director Craig Light said, if you would I would like that and I'll be happy to reach out to them. This has been an ongoing contract. We're required by the Federal Railroad to do monthly inspections of the track and of the crossings and this keeps us in compliance with that requirement. Councilmember Dr. Anthony Coleman said, absolutely. I just wanted to ensure that we were in discussion with them so that they understood what's going on. Thank you.

A RESOLUTION TO THE CITY COUNCIL OF JONESBORO, ARKANSAS AUTHORIZING THE OFFER AND ACCEPTANCE TO PURCHASE ADDITIONAL RIGHT-OF-WAY ON S. CARAWAY ROAD FOR THE PURPOSE OF THE CONSTRUCTING AND MAINTAINING DRAINAGE IMPROVEMENTS

WHEREAS, the City of Jonesboro, Arkansas desires to purchase the following described right-of-way for the purpose of constructing and maintaining drainage improvements:
