Whereas, State of Arkansas lease property, and city have agreed upon a right-of-way and a drainage easement for construction and maintenance of a street across the land of the State of Arkansas – DHS/DDS, in favor of city and in favor of the land of city.

1. State of Arkansas – DHS/DDS, in consideration of the agreement hereinafter made by city, grants to city a right-of-way and a drainage easement for construction and maintenance of a street over the land State of Arkansas – DHS/DDS, in City of Jonesboro, Craighead County, Arkansas, or particularly described as follows:

#### RIGHT OF WAY DEDICATION

A PART OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 4, TOWNSHIP 13 NORTH, RANGE 4 EAST IN CRAIGHEAD COUNTY, ARKANSAS, MORE PARTICULARLY DESCRIBED AS FOLLOWS;

COMMENCING AT THE NORTHWEST CORNER OF AFORESAID; THENCE SOUTH 347.94 FEET; THENCE N89°24'E 33.27 FEET TO THE POINT OF BEGINNING PROPER; THENCE S00°06'E 303.10 FEET; THENCE N89°24'E 3.5 FEET; THENCE N0°06'W 303.10 FEET; THENCE S89°24'W 3.5 FEET TO THE POINT OF BEGINNING PROPER; CONTAINING (1060.85 SQ.FT.) 0.024 ACRES, MORE OR LESS; AS SHOWN BY PLAT ATTACHMENT.

## 10 FEET TEMPORARY CONSTRUCTION EASMENT

- 2. State of Arkansas DHS/DDS, warrants the right of way and a drainage easement against anyone claiming it or in any manner preventing free and unobstructing use of it by city.
- 3. City, in consideration of the grant of right of way and a drainage easement aforesaid, agrees to construct, maintain and improve the property through the use as is set forth herein.
- 4. This agreement shall inure to and bind the heirs, executors, administrators, successors and assigns of the parties and shall constitute a covenant running with the land of State of Arkansas DHS/DDS.
