*Discussion was held concerning the committee being provided hard copies of the mosquito reports.*

*Mr. Jim Stark with Vector Disease Control explained they sprayed 19 nights during the month of August and had 918 spray miles, which is 33,298 acres. He noted they also had 65 service requests during the month of August.*

*He also gave an update on the West Nile Virus. He stated the State of Arkansas had 36 cases of the West Nile Virus with 4 deaths. He noted Randolph County is the closest county to Craighead County that had a case of the West Nile Virus. He added they are taking care of the hot spots that house the particular mosquito that carries the West Nile Virus on a daily basis.*

*He further explained that he received a call about the mosquitoes at the fair. He*

*apologized for not spraying at the fair on Monday night, but added they will be there the rest of the week.*

*He stated this will be his last report for the year, but he will email and will also send a hard copy of the year-end report to the Mayor. He noted he will come back in October if requested.*

*Councilman Moore explained there is no need to send a hard copy of the report if he will not be attending the meeting. Mr. Stark then asked if he needs to send it to all Council members. Mr. Moore answered either that or send the report to the City Clerk. City Clerk Donna Jackson stated the reports should continue being sent the way they have been because the City Clerk's Office is putting the information into Legistar.*

*Councilman Moore inquired if Vector Disease Control will be at the fair for the rest of the week. Mr. Stark answered they will spray at the fair for the rest of the week and will start spraying around 6 to 6:30 p.m.*

*Discussion was then held concerning spraying earlier during the day at the fair.*

*Mayor Perrin stated he would like to know how many flyovers that Vector Disease Control did this year. He then noted he would like to talk to Vector about whether or not the City could save money on their contract concerning the flyovers since Vector picked up several other towns around Jonesboro. Mr. Stark answered they have done 4 flyovers this year. He further explained he had planned to fly over the fairgrounds, but couldn't because of the wind and cooler weather.*
