Ms. Clements explained the funding agency likes to have the resolution approved before the application is submitted. She added if the City is awarded this project she will bring the resolution to the committee that will allow the City to enter into agreement.

She further explained this is for the Miracle League and is from the Parks and Tourism Grant. She added the City has raised \$1.5 million for the Miracle League, but they still have to raise \$800,000 for this project. She noted this resolution is for a new concession stand and a restroom, which will house an autistic room. She stated it will cost \$300,000 to build both facilities and the grant will be for \$150,000 with a \$150,000 match from the City. She noted the City has already received the in-kind match.

Councilman Fears asked if the City could apply for the full \$500,000. Ms. Clements answered yes, but the director told her the City will have a better chance at receiving the money if the City only applies for \$300,000 because the City received \$500,000 last year.

Councilman Fears stated the resolution needs to be amended to say up to \$500,000. Councilman Street motioned, seconded by Councilman Fears that this resolution be amended to say "up to \$500,000". All voted aye.
