### 8. MAYOR'S REPORTS

#### Mayor Perrin reported:

The staff is still working on the Employee Handbook. They hope to have it finished in the next two to three weeks.

The Corps of Engineers will be in town on February 21, 2010.

Work is being done on the 2011 and 2012 budgets. They hope to have those finished in the next few weeks so the Council can review them.

Bids are being secured for the gas wells at the landfill. The City is in post-closure with the landfill. Some of the wells are filling up with water and bids are being taken to correct those problems.

The real estate book that was made last year by the Engineering Department is being updated. It should be completed by the end of the month and everyone will receive a new copy. Recent property sales and swaps will be included. The Building Committee, chaired by Councilman Vance, will also receive copies so other properties can be bid out for sale.

They are in the process of converting all of the grant writing to the project manager.

The City of Jonesboro will start publishing newsletters to inform the public of what's

going on in the City. The first newsletter will hopefully go out at the beginning of March.

The Sanitation Department has worked out a deal concerning the recycling with the transfer station in Brookland in which the City employees will no longer have to wait to unload recycling. The recycling will then be picked up by Legacy Landfill at the transfer station. He thanked Sanitation Director Royce Leonard and Legacy Landfill for working the deal out, which will increase the efficiency of picking up and disposing of the recycling.

Lowe's has donated laminated flooring for the Earl Bell Community Center and it is in the process of being installed.

65% of the privilege licenses have been collected as of last Friday. He noted today is the last day to pay without a penalty.

The security lighting project at Parker Park and Miles Park that was recently approved by the Council has been given the notice to proceed. Parks Director Jason Wilkie is serving as project manager for that project.

They should be receiving an air permit and consent order from ADEQ in the next few weeks regarding the incinerator.

The park at Fort Rotary was recently recognized in a national magazine.

Mr. Light explained he has been minimally involved, but was informed by the Street Department that the intersection will be closed tomorrow and Thursday so the railroad can replace the at-grade crossing that will hopefully result in a smoother crossing.

Councilman Hargis reiterated his concerns about the need for a presentation concerning some of the items on the consent agenda. He stated some of the items, such as the item on tonight's consent agenda concerning the Turtle Creek Greenway, should have more information presented so the public will be better informed about the project. He explained more information could be given such as the timeline and what the project is including. Mayor Perrin stated Mr. Wilkie could make a presentation regarding those projects at the next Council meeting.
