Mayor Perrin explained a one-cent sales tax was passed state-wide for highway improvements and the City started receiving money in August. It will be approximately \$1.1 million per year for ten years. They have discussed the eastern bypass, with two alternate routes proposed. They spoke with the Highway Department, but have been unsuccessful to get funding for the eastern bypass. So, they came up with five or six projects that would affect a lot of people and they could get funding for.

Traffic Engineer Mark Nichols discussed the projects they have come up with. He provided the Council with a handout describing the projects (see attached).

Councilman Street asked about the project extending Parker Road from Strawfloor to Washington. Mr. Nichols explained Garver has completed their study and plan to present the findings to the Highway Department within the next few weeks. He stated the findings of the study were positive and showed that some traffic will be taken off Southwest Drive. He added he thinks that will also help with development in that area. The next step is to take the findings to the Highway Department to see if federal funds can be used for the project.

Councilman Fears discussed the exit ramp from Highway 63 South, turning on to Southwest Drive. He asked if they anticipated any improvements in that area because it can be hard to turn there in the afternoons. Mr. Nichols stated the Highway Department studied that area few years ago and suggested button-hooking the ramp into Parker Road, which would be a \$2 million to \$3 million project. They also studied it for a traffic signal, but found it would not be a good project due to the light at Southwest Drive and Parker. He noted it would be a good project, but it didn't make this list because the volume of traffic isn't high enough and the cost to benefit ratio isn't as good as the other projects. He added the project still needs to be done in the future.

Mayor Perrin explained the Planning Division of the Highway Department has been presented the information for these projects. He is waiting until after the Highway Department is able to review the information before being put on the agenda to make a presentation to them. He asked the Council to review the information and ask any questions they may have. He also stated they may have some public hearings to discuss the projects with the citizens. Mayor Perrin further explained they sent letters to the railroad companies concerning the trains sitting on the tracks for long periods of time.

Councilman Coleman asked if they have looked at the railroad crossing at Fisher Street because the trains sit on those tracks for long periods of time as well. Mr. Nichols explained they can send a letter to BNSF to let them know that it is causing a problem so they can remedy the situation. He added they can document that intersection as well and get video showing how long the trains sit on the tracks.

Councilman Moore questioned whether the State maintains a priority list for funding when it comes to cities sending in requests for project funding. Mayor Perrin stated he thinks they rate them, but they are going to take the list and ask for funding for each one of the projects. He noted someone from the Highway Department has already worked with the City to re-rank the projects for better results. Councilman Moore said he would like to see the list from the State so he can see where Jonesboro falls on the list. Mayor Perrin answered he can get the list from the Highway Department because it is of record.

8. MAYOR'S REPORTS

Mayor Perrin reported on the following items:

He and City Clerk Donna Jackson closed on the Monroe property and Krueger Drive property last week.

After reviewing the financials for the first six months of the year, he would like to purchase some fixed assets. The equipment will be about \$405,000. This will enable the Police Department to be more efficient with their K-9 units. They will purchase the equipment and do a cleanup ordinance at the end of the year.

They will also be adding four Street Department employees, three police officers and two firefighters. That ordinance will be brought before the Finance Committee for funding through the end of the year and the positions will be permanent in 2014.

They received an offer from Wolverine, but they did not like it. City Attorney Phillip Crego is sending a letter to Wolverine with hopes they can work something out to get the deeds to the property. They are already working with developers from other states who are interested in that area.

Renovations to the third floor of the Municipal Center have started. They will be meeting with the contractor in the morning. The original contract was \$2,594,000. The

change orders, not including the sidewalks, consist of 2.3%. The total with change orders, including the sidewalks and all change orders, is 5.4%.

He's noticed signs being put up in town. He reminded the public that if they are putting signs up in the public, regardless of the message, to first call the Code Enforcement Department because if the sign placement does not comply with city ordinances they will be taken down. He also stressed the City will not tolerate run-down homes and pointed out that the Council will condemn approximately 50 homes this year.

He announced this will be the last City Council meeting in the Huntington Building. The new Council Chambers will be ready for the August 20th meeting. The Chambers are located at 300 South Church in the Municipal Center. He thanked the Council for their support with the Municipal Center. After the third floor is finished, they will hold a reception and open house so everyone can tour the building.

Mr. Johnny Carson, 1406 Golf Course Drive, spoke to the Council regarding the city ordinance that prevents mobile vending. He owns a hot dog cart. He works in Paragould now and he would like to work in Jonesboro, but due to the ordinance he can't do that. He noted mobile vending units could generate money for the city if they are placed in areas such as Craighead Forest. He stated he could pay a fee to the City for having vending in the park. He noted he uses Petit Jean hot dogs, so they are from Arkansas. Councilman Moore questioned what the difference is between

Mr. Carson's hot dog cart and ice cream trucks that drive around town. Mr. Spriggs explained the city adopted an ordinance about three years ago concerning mobile vending and certain things were exempt, such as ice cream trucks that drive on the roads, because they were considered a different unit that continuously moves. He further explained the reasoning was to get the units off areas, such as street corners, where there were some safety issues. But, most cities do allow them downtown during special events. Councilman McCall then questioned whether there was any thought to reviewing the ordinance to address carts such as Mr. Carson's. Councilman Frierson recommended reviewing the ordinance and noted Little Rock has several mobile vending units. Councilman Moore suggested looking at the ordinance and possibly restricting it to certain zones and areas of town. Councilman Fears asked for Mr. Carson to email the Mayor to inform him of what areas in town he would like to put his hot dog cart.
