**JETS** 

Transit Coordinator Steve Ewart explained the City is in the process of getting grant funding for the old fire station at Matthews Avenue & Caraway Road so it can be used as a transfer station.

Councilwoman Williams asked if it will be a park and ride. Mr. Ewart answered no, because it will be a central point for buses so transferring can be more efficient. He added JETS currently does transferring, but the citizens have to wait. He noted this will allow the loops to be 30 minutes and it will also allow the days to be shortened to 13 hours from the current 14 hours. He further explained during the 5th stage the grant will allow the City to finance an overpass over the railroad tracks so the students at ASU can have better access to the transfer station. He added ASU's long range plan calls for an overpass over the Burlington Northern Railroad tracks so the students could have better access to the rugby fields.

Councilwoman Williams asked if the railroad was being helpful. Mr. Ewart answered no and the City will need help from some of the political delegates to help get the work done. Discussion was held concerning driver pay.

Discussion was held concerning a citizen who lives on South Culberhouse who has complained about not having access to JETS. Mr. Ewart stated the lady could use the paratransit service for now, but once the new routes go into effect that will change. He added that he informed the lady the City will not have service in that area for at least another 10 years because there is no demand for it in that area.
