Councilman Province noted several years ago someone looked at lighting up the bridge, but found it wasn't feasible. He added it might be feasible today, though. Mr. Wilkie stated he would look into lighting up the bridge.*

### **Discussion concerning Allen Park skateboard park**

*Mr. Wilkie discussed a recent meeting with parents of skateboarders concerning the skate park. He noted they agreed in the meeting to make renovations to the area. He also stated they discussed at the meeting the possibility of using the rest of the restitution money on the skate park. Councilman Hargis noted the recent letter in the Jonesboro Sun from one of the parents did not mention that tennis players had previously complained about the distraction the skate park was to those on the tennis courts.*

### **Highland Drive fire station**

*Councilman Province discussed the Mission Outreach group's proposal to lease or purchase the fire station on Highland for their program. He expressed concern over the amount of money the property might be worth. He also expressed concern over whether that was the best location for the Mission Outreach group. Discussion was held concerning leasing or selling the property. Councilman Province asked the committee to look at the information for further discussions.*
