ORDER OF ANNEXATION

On this 10th day of November, 1986, there comes on to be heard the petition of Melvin Brown, et al. for annexation to the City of Jonesboro certain lands lying contiguous to said city containing 2,960 acres, more or less and more particularly described as follows:

Tract 1: South Half of the Northwest Quarter, Northeast Quarter of the Southwest Quarter, the Northeast Quarter, the North Half of the Southeast Quarter, and the Southeast Quarter of the Southeast Quarter, all in Section 25, Township 14 North, Range 4 East.

Tract 2: North Half of the Northwest Quarter of Section 25, Township 14 North, Range 4 East, including all lots in Blocks A, B, C, D and E of Lazy Acres, a subdivision, and all publicly dedicated areas thereof: LESS AND EXCEPT all that part of the Northeast Quarter of Northwest Quarter of Section 25, Township 14 North, Range 4 East, lying South of the right of way of the Jonesboro-Lake City and Eastern Railroad, said exception containing 4 acres, more or less.

Tract 3: Northeast Quarter of the Northwest Quarter and North Half of the Northeast Quarter of Section 36, Township 14 North, Range 4 East.

Tract 4: Section 28, Township 14 North, Range 5 East.

Tract 5: Section 29, Township 14 North, Range 5 East.

Tract 6: Section 30, Township 14 North, Range 5 East.


Tract 7: North Half of the Northwest Quarter and North Half of the Northeast Quarter of Section 31, Township 14 North, Range 5 East.

Tract 8: North Half of the Northwest Quarter, Southeast Quarter of the Northwest Quarter, and Northeast Quarter of Section 32, Township 14 North, Range 5 East.

The court finds that said petition for annexation signed by a majority of the owners of the land in question was filed with the Clerk of this Court on October 10, 1986 and an amendment thereto was filed October 16, 1986; that the date for this hearing, the description of the lands in question and general contents of the petition were set out in a notice which was published in the Jonesboro Sun, a newspaper of general circulation in this county once a week for three weeks as required by law with proof of publication having been filed with the Clerk of this Court.

The Court finds that the allegations of the petition are true, that the limits of the territory to be annexed have been accurately described and an accurate map thereto reflecting the lands to be contiguous to the existing city limits of Jonesboro has been filed in this cause and that the prayer of the petition should be granted.

IT IS THEREFORE by the Court CONSIDERED, ORDERED and ADJUDGED that the above described lands be and the same are hereby annexed to the City of Jonesboro, subject only to confirmation by the City Council of the City of Jonesboro in a manner prescribed by law.
