WITH RELINQUISHMENT OF DOWER

Know All Men By These Presents:

THAT WE, J. A. Henderson

for and in consideration of the sum of Ten and no/100

(\$10.00) DOLLARS

and other good and valuable considerations to us in hand paid by Nelson Harvey Mosier and Mildred Mae Mosier, his wife, as tenants by the entirety, the receipt of which is hereby acknowledged

do hereby grant, bargain, sell and convey unto the said Nelson Harvey Mosier and

Mildred Mae Mosier, his wife, as tenants by the entirety

and unto their heirs and assigns forever, the following lands lying in the County of Craighead and

State of Arkansas, to-wit:

Part of the Northwest Quarter of the Northeast Quarter of Section 10, Township 14 North, Range 4 East, more particularly described as follows: Beginning at the Northeast corner of the Northwest Quarter of the Northeast Quarter of said Section 10; thence run South along the 40 acre line a distance of 555.1 feet to the South right of way line of State Highway No. 1; thence South 57° 57' West along said right of way line a distance of 391.8 feet to the point of beginning proper; thence South 32° 03' East 217.8 feet; thence run South 57° 57' West 200 feet; thence run North 32° 03' West 217.8 feet to the Southerly right of way line of State Highway No. 1; thence run North 57° 57' East 200 feet along said right of way line to the point of beginning proper, containing 1 acre, more or less.
