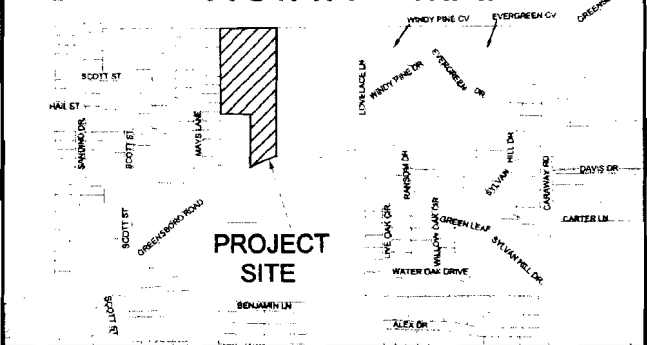

The following lands in Craighead County, Arkansas, to-wit: That part of the Wimberly's Subdivision of the Northwest Quarter of the Southeast Quarter and That part of the Northeast Quarter of the Southeast Quarter of Section 8, Township 14 North, Range 4 East, more particularly described as follows: Beginning at the Center of Section 8, Township 14 North, Range 4 East; thence N88°41'00"E along the North line of the Southeast Quarter of Section 8, 460.40 feet the true point of beginning, thence continue N88°41'00"E, 380.30 feet; thence S00°08'43"W, 872.16 feet; thence S89°23'28"W, 124.39 feet; thence S61°17'57"W, 65.80 feet; thence N00°23'57"E, 366.06 feet; thence S88°41'00"W, 206.60 feet; thence N00°00'58"E, 577.50 feet to the true point of beginning proper, containing 6.33 acres more or less. Subject to Road easement along the South side for Greensboro Road and any other easements that may affect said lands.
