UPDATE PRESENTATION BY MR. JIM STARK OF VECTOR MOSQUITO CONTROL

*Councilmember Chris Moore said, we have had a lot of compliments this year about the mosquito population so I hope I don't jinx you on that. Jim Stark from Vector Mosquito Control said, they should start draining the rice fields here in a couple of*

weeks and then all through the month of September so that is going to help us a lot. In the report for last month, we are up on our aerials. We are going to fly either tomorrow night or Thursday night and that will be number six. We will do two more and then we will take a look at it and we will do one before the fair. Overall, mosquito populations have not been that bad. I am not saying that they are not there. But, looking back over the years, they are nothing like they have been. That could be because there were not as many rice fields planted this year, but I don't know for sure. Or, it could be that we just hit a good year and that kind of makes me worry what is coming next year. I just wanted to come to see if there were any questions or if there was anything that you all needed from me or anything like that. Councilmember Bobby Long said, I have one question. On the spray that goes over the city, does that spray affect people's home gardens any at all? Does it not? It doesn't make leaves turn brown or anything? Mr. Stark said, no sir, it shouldn't. It shouldn't at all. It is only going out at about .0025 ounces an acre. It is such a minute spray anyway. Are you talking about the truck or the aircraft? Councilmember Long said, the aircraft. Mr. Stark said, the aircraft goes out at about .75 ounces an acre, but he is traveling at about 180 miles per hour. So, that gives you an idea of how dispersed that is as well. Councilmember Long said, ok. So, it wouldn't have any effect on any of the leaves or anything like that. Mr. Stark said, not unless the spray truck was to back up to the garden and sit there and spray and spray and spray, then, yes it may. But, if he is just driving by, then no. Councilmember Long said, good deal. Thank you. Mr. Stark said, sure. Anytime you all need anything, you all know who to call.
