4. Remove old sidewalk and construct new sidewalk at back of curb for width of property.
5. Backfill, landscape, and resod all area disturbed by tree removal and street construction.

NOTE: Retaining wall to be constructed by owner.

The above said agreed amount to be paid shall be free and clear of any and all encumbrance with the exception of Bank of America

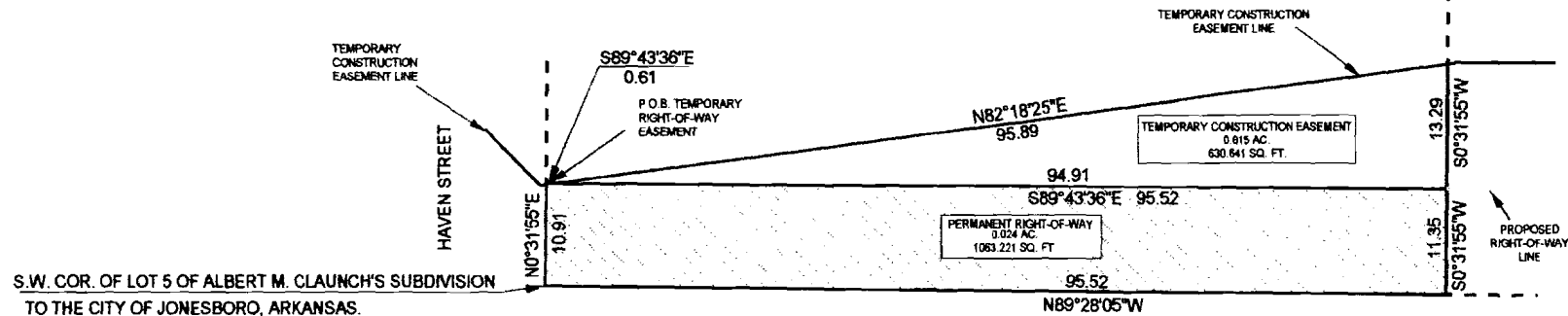

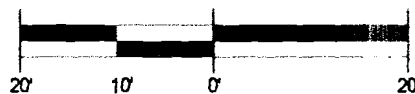

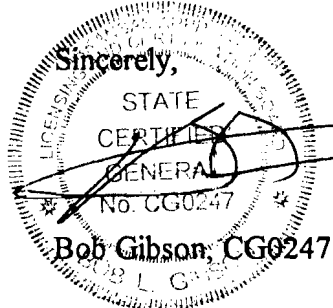

Dear Mr. Scott:

I have appraised the above property as of October 12, 2000, and find the market value to be \$16,632. In accordance with your instructions, I have reduced the lot size by the "amount of taking" for the purpose of widening Nettleton Street. The remaining value is \$14,931 or a difference of \$1,701 which is the just compensation due the owner. In addition, a temporary easement is being used in the amount of 630.641 sq ft. A fee of \$150 is paid for this inconvenience. A fee of \$1,500 is paid for damage of a tree and other landscaping bringing total compensation to \$3,351.

The purpose of this appraisal is to give a fair market value of the land taken by the City of Jonesboro for the expansion of Nettleton Ave. The subject at 412 W Nettleton will lose a tract of land: 1063.221 sq ft

The value of the improvements has not been affected. Therefore, the assessed value of \$115,700 has not been used in the appraisal. The set back should not affect the driveway and the entrance to the improvements.

DEFINITION OF MARKET VALUE: The most probable price which a property should bring in a competitive and open market under all conditions requisite to a fair sale, the buyer and seller, each acting prudently, knowledgeably and assuming the price is not affected by undue stimulus. 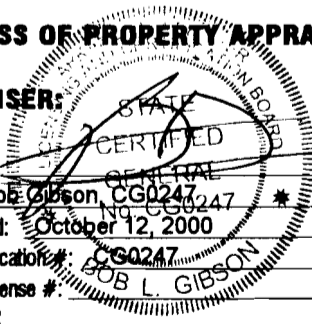

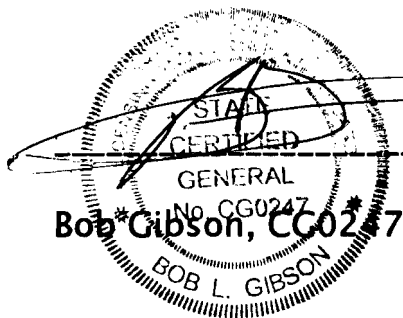
