ADVERTISING AGREEMENT FOR FIELD SIGN LOCATEDAT SOUTHSIDE SOFTBALL COMPLEX

This agreement is made by and between <u>Zaxby's</u>, <u>Inc</u> (SPONSOR) and the CITY OF JONESBORO PARKS AND RECREATION DEPARTMENT (CITY), on this <u>20th</u> Day of <u>January</u>, <u>2012</u> (the "Effective Date").

NOW, THEREFORE in consideration of the promises and the reciprocated coven nts and obligations contained herein, the parties agree as follows:

I. Term

(1) The term of this agreement is for a period of (3) three years commencing on the effective Date and ending at midnight on the (3rd) third anniversary thereof.

II. Advertisement at Facilities

- (1) It is agreed between the parties hereto, in return for the covenants and conditions set forth herein that the SPONSOR's logo shall be put on a : ign to be displayed on chosen field at FACILITY for a period of (3) three ye: rs.
- (2) It is agreed between the parties that the SPONSOR shall pay over a per od of 3 years for the sign and sponsorship the total sum of \$900.00.

A sum of \$300.00 shall be paid on February 1st, 2012.

A sum of \$300.00 shall be paid on February 1st, 2013.

A sum of \$300.00 shall be paid on February 1st, 2014.

- (3) It is agreed between the CITY and the SPONSOR that the SPONSOR and have the right to renew this contract for an additional period of (3) thre years at the sponsorship rate to be negotiated at the time of the renewal.
- (4) It is agreed between the CITY and the SPONSOR that this sponsorship is non-assignable without prior written approval of the CITY. It is also a reed that the CITY reserves the right to remove SPONSOR'S sign and obtain a new sponsor for designated field in the event of failure of payment on the part of the SPONSOR.
- (5) It is agreed between the parties that the CITY will furnish a 4' x 6' sign to be placed for SPONSOR'S designated field. However, it shall be the responsibility of SPONSOR to bear any expense made to said sign should changes be requested during the term of this agreement.
- (6) It is agreed by CITY and the SPONSOR that the SPONSOR shall not the responsible for the maintenance or upkeep of sign and SPONSOR shall not be responsible with regards to any liability actions which may be brought against the CITY resulting from accidents which might involve the sign.

III. Assignability and Exclusivity

This agreement is a privilege for the benefit of SPONSOR only and may not the assigned in whole or in part by SPONSOR to any other person or entity.

IV. Miscellaneous Provisions.

- (1) No Modification of this Agreement shall be effective unless it is made in writing and signed by the authorized representative's of the parties hereto.
- (2) This agreement shall be construed under and in accordance with the laws of the State of Arkansas and venue for any litigation concerning this Agreement shall be in Craighead County, Jonesboro, Arkansas.
- (3) Nothing in this Agreement shall be construed to make the CITY or its respective agents or representatives liable in situations it is otherwise imm ane from liability.

- (4) In case any one or more of the provisions contained in this Agreement shall for any reason be held invalid, illegal or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provision thereof and this Agreement shall be construed as if such invalid, illegal, or unenforceable provision had never been contained herein.
- (5) Each party represents to the other the individual signing this Agreement below has been duly authorized to do so by its respective governing body: nd that this Agreement is binding and enforceable as to each party.
