Chairman Joe Hafner said, I was kind of thrown, because if that's the same Grover Evans I think he passed away. Councilmember John Street said, I was thinking that myself. City Clerk April Leggett said, they did a search on that, and it is not.

Chairman Joe Hafner said, hey Brian, would it be possible for Finance or Collector's offices to send us, maybe, last couple of years how much they've been paid that they've collected on municipal liens? We got an update before, but it's been two or three years ago. Chief Administrative Officer Brian Richardson approached the podium and said, sure, we can request that. And, of course, we just went through 20 something liens, and I don't want to pass up on a chance to give a shout out to Code Enforcement. And I know Eric's in the room and Scott Roper. For everyone that makes it here there's 10 to 15 cases that they resolve without ever having to actually go through the final lien process. Those guys and ladies down there do a great job, and we certainly appreciate them. Chairman Joe Hafner said, yeah, no doubt.

Chairman Joe Hafner said, hey Brian, I just have a couple questions. The grant was for \$1,200,000, but it talks about BNSF partner for the match is 10% or \$150,000 so

that's \$1,500,000. Are we each giving \$150,000 for a total of \$300,000? Chief Administrative Officer Brian Richardson approached the podium and said, so there was an agreement worked out with BNSF that they would pay up to 5% of the total cost of the grant but not greater than \$150,000. Is that right? Okay, so BNSF basically said we're in for \$150,000 and if our match comes in a little less than that then I'm sure we'll... Chairman Joe Hafner said, all right, so is the total the \$1,365,683? That's the total of the agreement? Brian Richardson said, that's the cost of the proposal that we were sent over. And then, so the grant is \$1,200,000, so then our local match for that system was 10%. So instead of BNSF agreeing to a percentage, they just agreed to an amount that would be roughly about that 10%. Chairman Joe Hafner said, all right.

Councilmember Dr. Charles Coleman said, I have a question. Are they going to do any design work? Brian Richardson said, I'll let Craig speak to the bones of the study. Engineering Department Director Craig Light approached the podium and said, they will get the projects to 30% plans. So, they'll go through and study all the intersections. Make all the recommendations. We'll approve those and then they'll develop drawings up to 30% plans for them. Councilmember Dr. Charles Coleman said, so once they do the 30%, is that more money we're going to be involved in? Director Craig Light said, yeah, I mean at that point we'll start seeking additional funding to get them to 100% plans and get them constructed. But that'll get us a good idea of where we need to be for their construction projects that we need to get funded in the phasing of those projects.

Councilmember David McClain said, Craig you mentioned getting them to plan. What kind of construction are we starting or will we have on the different rail crossings? Is this for looking at overpasses or are we looking at something else? Director Craig Light said, yeah, they had a list in the grant agreement, the original grant application, of different types of treatments, consolidations of crossings and then possible bridges, possible rail relocation in areas. There are 18 crossings, so they're going to look at all of them. But then they'll design those. Councilmember Dr. Charles Coleman said, does that include the one down on Dan Avenue down here? Director Craig Light said, yeah. It's all of them on the Burlington Northern track starting at Henson Road and going all the way to Cottage Home Road down by Bay.

Chief Administrative Officer Brian Richardson approached the podium and said, and just to add for people that maybe listening or watching from their tv sets or computers at home. You know that the significance of the 30% conceptual plan design for some of these, the purpose of that is to provide you with the type of information that you need to actually seek a capital build type grant for a railroad overpass. This is essentially a planning grant, and at the end of the day what they're going to do is give us kind of a portfolio of projects that you're almost seeking a capital grant to actually construct the project instead of further planning documents. You know there's a lot of grants out there that really strive for you to have that kind of information. A lot of your homework is done before they're going to take their time reviewing. Possibly allocating \$15,000,000, \$20,000,000, \$30,000,000 on an overpass project or any kind of rail reduction project. Councilmember Dr. Charles Coleman said, I kind of know what the answers are going to be, but I guess my major question was being understaffed, they just need all the help they can get if we're going to pay out that much money then he needs to get as much help as he can get. Brian Richardson said, and I agree. Our staff is skilled in a lot of different things but exactly designing out some of these railroad crossings is a lot of work. 30% isn't a conceptual drawing, I mean, you're actually starting to get through to some real facts and figures and yardages and earth movement stuff like that. So, at the end of this study we anticipate that we're going to receive several highlighted interchanges at railroad crossings that we'll have the


